Sir

I have the honour to refer to the British Expatriates Supplementation (Malawi) Agreement 1971 as amended (hereinafter referred to as "the Agreement") and to propose:

- (a) that paragraph 1 of the Agreement be amended by substituting for the words "Overseas Development and Service Act 1965" the words "Overseas Development and Co-operation Act 1980"; and
- (b) that the second annex to the Agreement, which consists of a list of organisations and institutions, be amended by adding to the said list the name of the following organisation "Malawi Railways".

If this proposal is acceptable to the Government of Malawi, I have the honour to suggest that this letter and your reply shall constitute an agreement between our two Governments which shall enter into force on 1 August, 1985 and which shall be cited, together with the Agreement, as the British Expatriates Supplementation (Malawi) Agreement 1971–1985.
