## BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE KINGDOM OF LESOTHO AMENDING AND EXTENDING THE OVERSEAS SERVICE (LESOTHO) (CONTINUANCE) AGREEMENT 1971/81 (THE OVERSEAS SERVICE (LESOTHO) (CONTINUANCE) AGREEMENT 1971/86)

The United Kingdom High Commissioner at Maseru to the Minister of Foreign Affairs of the Kingdom of Lesotho.

Your Excellency

I have the honour to refer to the Overseas Service (Lesotho) Agreement 1971 (hereinafter referred to as "the Agreement"), as amended by the Overseas Service (Lesotho) (Continuance) Agreement 1971/76 and the Overseas Service (Lesotho) (Continuance) Agreement 1971/81, and to propose that the Agreement be amended:

- (a) by deleting in sub-paragraph 14 of paragraph 1 the words and figures "31 March 1986" and substituting therefor the words and figures "31 March 1991"; and
- (b) at the end of sub-paragraph (b) of paragraph (4) add a further sentence to read as follows:

"The Government of the United Kingdom shall, after consultation with and on behalf of the Government of Lesotho, reimburse the outward passage costs directly to an agent of the Government of Lesotho within the United Kingdom."

If these proposals are acceptable to the Government of Lesotho, I have the honour to suggest that this Note and Your Excellency's reply shall constitute an Agreement between our two Governments which shall be deemed to have entered into force on 31 March 1986, and which shall be cited as the Overseas Service (Lesotho) (Continuance) Agreement 1971/86.

I avail myself of this opportunity to renew to Your Excellency the assurance of my highest consideration.

Your Excellency

I have the honour to acknowledge receipt of Your Note AID 093/4 of 22 December 1986 regarding proposals for the continuance of the Overseas Service (Lesotho) Agreement which reads as follows:

- "I have the honour to refer to the Overseas Service (Lesotho) Agreement 1971 (hereinafter referred to as "the Agreement"), as amended by the Overseas Service (Lesotho) (Continuance) Agreement 1971/76 and the Overseas Service (Lesotho) (Continuance) Agreement 1971/81, and to propose that the Agreement be amended:
- (a) by deleting in sub-paragraph 14 of paragraph 1 the words and figures "31 March 1986" and substituting therefor the words and figures "31 March 1991"; and

(b) at the end of sub-paragraph (b) of paragraph (4) add a further sentence to read as follows:

I have the honour to inform you that the foregoing proposals are acceptable to the Government of Lesotho who therefore agree that Your Excellency's Note and this reply shall constitute an Agreement between our two Governments which shall be deemed to have entered into force on 31 March 1986 and which shall be cited as the Overseas Service (Lesotho) (Continuance) Agreement 1971/86.
