Her Britannic Majesty's Embassy present their compliments to the Ministry of Foreign Affairs of the Union of Soviet Socialist Republics and has the honour to refer to discussions which took place in Moscow from 25 March to 27 March 1987 between the aeronautical authorities of the government of the United Kingdom of Great Britain and Northern Ireland and the government of the Union of Soviet Socialist Republics. During these discussions, it was agreed in principle that certain changes should be made to the agreement between the government of the United Kingdom of Great Britain and Northern Ireland and the government of the United Kingdom of Great Britain and Northern Ireland and the government of the United Kingdom of Great Britain and Northern Ireland and the government of the United Kingdom of Soviet Socialist Republics signed at Moscow on 19 December 1957^{1,2} as amended by the exchanges of notes on 22 September / 14 October 1960³ and 11 February / 14 April 1969⁴ (hereinafter referred to as "The Agreement").

In accordance with the decisions reached during those discussions the Embassy has the honour to propose on behalf of the government of the United Kingdom that the Agreement be amended as set out below.

1. In article 1, paragraph (i), insert "and between Moscow and Manchester" after the words "and between Leningrad and London".

- 2. In article 1, paragraph (3),
 - (a) in sub-paragraph (a), add point (iii)
 "between Manchester and Moscow and between Manchester and intermediate stopping points situated in the territory of third countries".
 - (b) in sub-paragraph (b), add point (iii)"between Moscow and Manchester and between Moscow and intermediate stopping points situated in the territory of third countries".
- 3. In article 3, paragraph (i), insert the words:

"and between Manchester and Moscow" after the words "and between London and Leningrad".

- 4. In article 7, paragraph (5)
 - (a) in the first sentence after the words "overnight in London" add the words "or in Manchester".
 - (b) In the second sentence after the words "or London" add the words "or Manchester".

5. In article 8, in paragraph (4) delete the words "either in London or in Moscow or in Leningrad" and substitute the words "either in the United Kingdom or the USSR".

6. In article 8, paragraph (5) delete the words "in sterling in London or in Roubles in Moscow or in Leningrad" and substitute the words "in sterling in the United Kingdom or in Roubles in the USSR".

If the foregoing proposal is acceptable to the government of the Union of Soviet Socialist Republics, the Embassy has the honour to propose that this note and the reply on behalf of the Soviet government to that effect shall constitute an agreement between the two governments in this matter which shall enter into force on the date of the Ministry's reply.

In accordance with the decision reached during those discussions the Embassy has the honour to propose on behalf of the government of the United Kingdom that the agreement be amended by adding a new article 13 BIS reading as follows:

"Article 13 BIS

(1) consistent with their rights and obligations under international law, the contracting parties reaffirm that their obligation to each other to protect the security of civil aviation against acts of unlawful interferences forms an integral part of this agreement. Without limiting the generality of their rights and obligations under international law, the contracting parties shall in particular act in conformity with the provisions of the Convention on Offences and Certain other Acts Committed

On Board Aircraft signed at Tokyo on 14 September 1963⁸, the Convention of the Suppression of Unlawful Seizure of Aircraft, signed at The Hague on 16 December 1970⁹ and the Convention for the Suppression of Unlawful Acts Against the Safety of Civil Aviation, signed at Montreal on 23 September 1971¹⁰.

(2) the contracting parties shall provide upon request all necessary assistance to each other to prevent acts of unlawful seizure of civil aircraft and other unlawful acts against the safety of such aircraft, their passengers and crew, airports and air navigation facilities, and any other threat to the security of civil aviation.

(3) the contracting parties shall, in their mutual relations, act in conformity with the aviation security provisions established by the International Civil Aviation Organisation and designated as annexes to the Convention on International Civil Aviation¹¹ to the extent that such security provisions are applicable to the parties: they shall require that operators of aircraft of their registry or operators of aircraft who have their principal place of business or permanent residence in their territory and the operators of airports in their territory act in conformity with such aviation security provisions.

(4) each contracting party agrees that such operators of aircraft may be required to observe the aviation security provisions referred to in paragraph (3) above required by the other contracting party for the entry into, departure from, or while within, the territory of that other contracting party. Each contracting party shall ensure that adequate measures are effectively applied within its territory to protect the aircraft and to inspect passengers, crew, carry-on items, baggage, cargo and aircraft stores prior to and during boarding or loading. Each contracting party shall also give sympathetic consideration to any request from the other contracting party for reasonable special security measures to meet a particular threat.

(5) when an incident or threat of an incident of unlawful seizure of civil aircraft or other unlawful acts against the safety of such aircraft, their passengers and crew, airports or air navigation facilities occurs, the contracting parties shall assist each other by facilitating communications and other appropriate measures intended to terminate rapidly and safely such incident or threat thereof."

If the foregoing proposal is acceptable to the government of the Union of Soviet Socialist Republics, the Embassy has the honour to propose that this note and the reply on behalf of the government of the Union of Soviet Socialist Republics to that effect shall constitute an agreement between the two governments in this matter which shall enter into force on the date of the Ministry's reply."
