## EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF THE

### UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE ITALIAN REPUBLIC TERMINATING ARTICLE 28 AND AMENDING ARTICLE 29 OF THE CONSULAR CONVENTION, SIGNED AT ROME ON 1 JUNE 1954

Her Majesty's Ambassador at Rome to the Minister for Foreign Affairs of Italy

British Embassy Rome 18 October 1988

Your Excellency,

I have the honour to refer to the Consular Convention between the United Kingdom of Great Britain and Northern Ireland and the Italian Republic, signed at Rome on 1 June 1954<sup>1</sup>, and to the related Exchange of Notes of the same date<sup>1</sup>. Acting on instructions from Her Majesty's Principal Secretary of State for Foreign and Commonwealth Affairs, I have to propose to Your Excellency that Article 28 of the said Convention, which provides for mutual assistance in the recovery of merchant seamen deserters, shall cease to have effect.

Furthermore, I have the honour to propose that in Article 29:

- (a) the English text of paragraph (2)(b)(iii)(II) shall be amended to read:
   "(II) in the case of the territories referred to in paragraph (2) of that Article, an offence punishable, under the laws of the receiving State, by imprisonment for a minimum of at least two years";
- (b) the Italian text of paragraph (2)(b)(iii)1° shall be amended to read:
  "I° nel caso dei territori di cui al paragrafo (1) dell'Articolo 1, quando si tratta di un reato punibile secondo le leggi dello Stato di residenza con una pena detentiva non inferiore, nel minimo, a due anni".

If the foregoing proposals are acceptable to the Italian Republic, I have the honour to suggest that this Note and Your Excellency's reply to that effect shall be regarded as constituting an Agreement between the United Kingdom of Great Britain and Northern Ireland and the Italian Republic in this matter, which shall enter into force on the date on which the Government of the United Kingdom acknowledges receipt of the notification by the Italian Republic that the procedures required under Italian law in order to render the Agreement applicable within the territory of the State have been completed and which shall apply, on the part of the United Kingdom, to the United Kingdom and to those territories for whose international relations the United Kingdom is responsible for which the said Convention is in force at the said date.

I avail myself of this opportunity to renew to Your Excellency the assurance of my highest consideration.
