# EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF THE

## UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE HASHEMITE KINGDOM OF JORDAN CONCERNING THE UNITED KINGDOM/JORDAN DEBT RESCHEDULING AGREEMENT 1990

### Your Excellency,

- 1. I have the honour to refer to discussions between representatives of the Government of the United Kingdom of Great Britain and Northern Ireland, hereinafter known as the Government of the United Kingdom, and the Government of the Hashemite Kingdom of Jordan, hereinafter known as the Government of Jordan, under the terms of the Agreed Minute on the consolidation of the Debt of the Government of Jordan signed in Paris on 19 July 1989 concerning the Exchange of Notes, (EON), constituting the loans listed as follows:
- (a) the United Kingdom/Jordan Development Loan 1966/67, (EON signed at Amman and dated 25 and 26 July 1966);
- (b) consolidation and modification of United Kingdom/Jordan Development Loans 1950/66, (EON signed at Amman and dated 19 March 1967);
- (c) the United Kingdom/Jordan Development Loan 1967, (EON signed at Amman and dated 9 and 15 August 1967);
- (d) the United Kingdom/Jordan Development Loan 1968, (EON signed at Amman and dated 29 and 30 July 1968);
- (e) the United Kingdom/Jordan Development Loan 1969, (EON signed at Amman and dated 9 and 14 January 1969);
- (f) the United Kingdom/Jordan Development Loan 1969, (EON signed at Amman and dated 19 and 27 March 1969);
- (g) the United Kingdom/Jordan Development Loan 1969, (EON signed at Amman and dated 8 and 24 May 1969);
- (h) the United Kingdom/Jordan Development Loan 1969, (EON signed at Amman and dated 1 and 13 October 1969);
- (i) the United Kingdom/Jordan Development Loan 1970, (EON signed at Amman and dated 4 and 15 March 1970);
- (j) the United Kingdom/Jordan Development Loan 1971, (EON signed at Amman and dated 25 February and 3 March 1971);
- (k) the United Kingdom/Jordan Development Loan 1971, (EON signed at Amman and dated 13 and 15 September 1971);
- (1) the United Kingdom/Jordan Development Loan 1972, (EON signed at Amman and dated 3 and 4 March 1972);
- (m) the United Kingdom/Jordan Development Loan 1972, (EON signed at Amman and dated 3 and 10 October 1972);
- (n) the United Kingdom/Jordan Development Loan 1973, (EON signed at Amman and dated 6 and 8 March 1973);
- (o) the United Kingdom/Jordan Development Loan 1973, (EON signed at Amman and dated 11 and 14 June 1973 as amended by EON signed at Amman and dated 30 March and 3 April 1976 as further amended by EON signed at Amman and dated 17 and 21 April 1979);

- (p) the United Kingdom/Jordan Development Loan for Afforestation, Electricity and Phosphates Projects 1973, (EON signed at Amman and dated 4 and 10 September 1973);
- (q) the United Kingdom/Jordan Development Loan for Afforestation and Electricity Projects 1974, (EON signed at Amman and dated 18 and 25 February 1974);
- (r) the United Kingdom/Jordan Development Loan 1975, (EON signed at Amman and dated 8 and 10 March 1975);
- (s) the United Kingdom/Jordan Development Loan 1977, (EON signed at Amman and dated 21 March 1977);
- (t) the United Kingdom/Jordan Construction Work/Arab Potash Company Loan 1979, (EON signed at Amman and dated 14 March 1979);
- (u) the United Kingdom/Jordan Amman Electricity Project Loan 1980, (EON signed at Amman and dated 4 November 1980);
- (v) the United Kingdom/Jordan Loan 1982, (EON signed at Amman and dated 14 March 1982);
- (w) the United Kingdom/Jordan Loan 1987 No. 1 (EON signed at Amman and dated 1 October 1987); hereinafter referred to as "the aid loans".
- 2. My Government proposes that the repayment schedule of the aid loans in respect of those repayments of principal due on or after 1 July 1989, up to and including 31 December 1990, and 50 per cent of the interest (excluding late interest) due on or after 1 July 1989 up to and including 31 December 1989, and which remain unpaid, shall be revised as follows:
- (a) 100 per cent of the amounts of principal due from 1 July 1989 to 31 December 1990 and 50 per cent of the interest (excluding late interest), due from 1 July 1989 to 31 December 1989 inclusive (hereinafter referred to as "deferred amounts") shall be paid by the Government of Jordan in pounds sterling in London to the Government of the United Kingdom in 10 equal and successive semi-annual payments, the first payment to be made on 30 September 1995, (end of grace period), and the final payment to be made on 31 March 2000, (end of the repayment period).
- (b) the remaining 50 per cent of the interest due from 1 July 1989 up to 31 December 1989 inclusive, and also interest payments not covered by this rescheduling shall be paid as soon as possible by the Government of Jordan in pounds sterling in London to the Government of the United Kingdom.
- 3. The sums to be paid in accordance with paragraphs 2(a) and (b) above are specified in Annex I, I(a), and II respectively to this Note.
- 4. My Government also proposes that amounts due as at 30 June 1989 which remain unpaid shall be revised as follows:
- (a) 100 per cent of the amounts of principal and interest, (excluding late interest), due as at 30 June 1989 inclusive and not paid (hereinafter referred to as "outstanding amounts"), shall be paid by the Government of Jordan in pounds sterling in London to the Government of the United Kingdom in 10 equal successive semi-annual payments, the first payment to be made on 30 September 1994, (end of grace period), and the final payment to be made on 31 March 1999 (end of repayment period).
- 5. The sums to be paid in accordance with para 4 above are specified in Annex III and III(a) to this Note.
- 6. No interest shall be charged on the deferred amounts and the outstanding amounts rescheduled and described in paragraphs 2 and 4 above. Repayment of principal and interest on the loans included in paragraph 1 of this Note which do not come within the rescheduled amounts set out in paragraphs 2 and 4 above shall be made according to the original maturity schedules at the original rates of interest. The Terms and conditions of these loans shall continue to persist.

7. If these terms and conditions are acceptable to the Government of Jordan, I have the honour to propose that this Note together with its Annexes and your reply to that effect shall constitute an agreement between our two Governments in this matter which shall be known as the United Kingdom/Jordan Debt Rescheduling Agreement 1990 and which shall enter into force on the date of your reply.

8. I have the honour to convey to Your Excellency the assurance of my highest consideration.

### ANNEX I

### UK/Jordan Debt Rescheduling 1989

A. 100 per cent of the amounts of principal due from 1 July 1989 to 31 December 1990 inclusive and 50 per cent of the amounts of interest due from 1 July 1989 to 31 December 1989 inclusive, will be rescheduled. Repayment of the rescheduled amount will be made in 10 equal and successive semi-annual payments, between 30 September 1995 and 31 March 2000.
