# EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE REPUBLIC OF POLAND FURTHER AMENDING THE AGREEMENT ON CIVIL AIR TRANSPORT SIGNED AT WARSAW ON 2 JULY 1960

The British Chargé d'Affaires at Warsaw to the Minister of Foreign Affairs of the Polish People's Republic

British Embassy Warsaw 16 January 1991

Your Excellency

I have the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Polish People's Republic concerning Civil Air Transport, signed at Warsaw on 2 July 1960<sup>1</sup> as amended by the Exchanges of Notes of 12 December 1979 and 30 January 1980<sup>2</sup>, of 20 June and 13 July 1988<sup>3</sup> and of 8 August and 11 September 1989<sup>4</sup>.

I now have the honour, in accordance with Article 12, paragraph 4, of the said Agreement, to propose that the Annex to the Agreement should be replaced by the Annex attached to this Note.

If this proposal is acceptable to the Government of the Republic of Poland, I have the honour to propose that this Note and its Annex together with Your Excellency's reply in that sense shall constitute an Agreement between our two Governments in this matter which shall enter into force on the date of Your Excellency's reply.

I avail myself of this opportunity to renew to Your Excellency the assurance of my highest consideration.

#### **ANNEX**

#### SCHEDULE 1

Routes to be operated by the designated airline or airlines of the United Kingdom:

A. London and/or Manchester—one intermediate point as desired—Berlin—Warsaw and/or Krakow and/or Gdansk and/or Szczecin—Moscow.

The designated airline or airlines of the United Kingdom may on all or any flights omit calling at any of the above points, provided that the agreed services on the route begin at a point in United Kingdom territory.

B. Berlin-Warsaw.

#### SCHEDULE 2

Routes to be operated by the designated airline or airlines of the Republic of Poland:

A. Warsaw and/or Krakow and/or Gdansk and/or Szczecin—Berlin—one intermediate point as desired—London and/or Manchester—Dublin.

The designated airline or airlines of the Republic of Poland may on all or any flights omit calling at any of the above points, provided that the agreed services on the route begin at a point in Polish territory.

B. Berlin-London.
