EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE HASHEMITE KINGDOM OF JORDAN AMENDING THE UNITED KINGDOM/JORDAN LOAN AGREEMENT 1987

Excellency,

I have the honour to refer to the United Kingdom/Jordan Loan Agreement 1987¹ (hereinafter referred to as "the Loan") and to propose that the sum not exceeding Pds 10,000,000 which it was the intention of my Government to make available to your Government by way of a loan, be reduced by Pds 6,352,007 (six million, three hundred and fifty-two thousand, and seven pounds sterling) to a sum not exceeding Pds 3,647,993 (three million, six hundred and forty-seven thousand, nine hundred and ninety-three pounds sterling).

- 2. Accordingly, I have the honour to propose that the figures and words "Pds 10,000,000 (ten million pounds sterling)" in paragraph 1 of the Loan be deleted and the figures and the words "Pds 3,647,993 (three million, six hundred and forty-seven thousand, nine hundred and ninety-three pounds sterling)" be substituted therefor and that discussions should continue between our two Governments over Technical Co-operation projects to be financed from an allocation not exceeding Pds 6,352,007 (six million, three hundred and fifty-two thousand, and seven pounds sterling).
- 3. In addition, I have the honour to propose, with reference to paragraph B2 of the "Procedures and Practices for the Expenditure of United Kingdom Capital Aid Resources" accompanying the Loan, that a letter from your Government, in the form shown in Annex A to this Note, be sent to the Crown Agents for Overseas Governments and Administrations.
- 4. If the proposals set out above are acceptable to your Government, I have the honour to propose that the present Note together with Your Excellency's reply in that sense shall constitute an Agreement between our two Governments which shall enter into force on the date of Your Excellency's reply, amending the United Kingdom/Jordan Loan Agreement 1987.

FROM THE GOVERNMENT OF JORDAN TO THE CROWN AGENTS FOR OVERSEAS GOVERNMENTS AND ADMINISTRATIONS

Dear Sirs,

I refer to our letter of 19 confirming your appointment as agents of the Government of Jordan in connection with the management in the United Kingdom of the United Kingdom/Jordan Loan Agreement 1987 (hereinafter referred to as "the Loan") and hereby inform you that following a further Exchange of Notes between the Government of Jordan and the Government of the United Kingdom, the amount of the Loan has been reduced from a sum not exceeding Pds 10,000,000 (ten million pounds sterling) to a sum not exceeding Pds 3,647,993 (three million, six hundred and forty-seven thousand, nine hundred and ninety-three pounds sterling).

Otherwise the terms and conditions of your appointment as agents of the Government of Jordan remain unchanged.
