EXTRADITION (continued)

Declarations*

1. In respect of Article 3

As the legislation of the Republic of Armenia does not define the notion of "political offence" or that of "offence connected with a political offence", the Republic of Armenia, being requested for extradition on such grounds, will grant extradition if the offence mentioned in the request is considered as such under its ordinary criminal law or under the International Treaties in force in the Republic of Armenia.

2. In respect of Article 4

As all military offences are under the ordinary criminal law of the Republic of Armenia, extradition requested by another Party will be granted if the offence, in respect of which the request for the extradition is made, is also under ordinary criminal law of the requesting Party.

3. In respect of Article 6

Pursuant to sub-paragraph a of paragraph 1 of Article 6, the Republic of Armenia declares that it will not extradite its nationals.

Pursuant to sub-paragraph c of paragraph 1 of Article 6, nationality of the Republic of Armenia within the meaning of this Convention shall be determined at the time of the decision concerning extradition.

4. In respect of Article 16

Provisional arrest, provided in paragraph 4 of Article 16, will be terminated in any case, if, within a period of one month after arrest, the requested Party has not received the request for extradition and the documents mentioned in Article 12.

5. In respect of Article 23

The request for extradition and documents to be produced shall be accompanied by a certified translation into the Armenian language or into one of the official languages of the Council of Europe.

Declarations+

Georgia declares that it will not grant the extradition of any person in respect of offences punishable by death under the law of the requesting Party.

In respect of Article 6, paragraph 1b, the term "national" within the meaning of the Convention will be applied as it is determined by the legislation of Georgia.

In a case of transit under Article 21 of the Convention, Article 11 of the Convention will be applied mutatis mutandis.

In respect of Article 21 of the Convention, Georgia reserves the right not to grant transit under the same conditions on which it grants extradition.

In respect of Article 23 of the Convention, where the request for extradition and the documents to be produced are not in Georgian language, they must be accompanied by a translation of the request and the documents into English or Russian languages.

Georgia will not be responsible for the application of the provisions of the Convention on the territories of Abkhazia and Tskhinvali region until the full jurisdiction of Georgia is restored over these territories.

Reservations*

In conformity with Article 26 of the European Convention on Extradition the Republic of Armenia makes the following reservations:

EXTRADITION (continued)

- 1. In respect of Article 1 of the Convention, the Republic of Armenia reserves the right to refuse to grant extradition:
- a. if the person to be extradited will be brought before an extraordinary court or in respect of the person who is to serve a sentence passed by such a court;
- b. if there are sufficient grounds to suppose that in result of the person's state of health and age her/his extradition will be injurious to her/his health or threaten her/his life;
- c. if political asylum is granted in the Republic of Armenia to the person, whose extradition is requested.
- 2. The extradition for the serving of a sentence, provided in Article 2, paragraph 1 of the Convention, will be granted if the person, whose extradition is requested, has been convicted for a period of at least six months or a more severe penalty.

Reservations+

For the purposes of this Convention, the Government of Georgia reserves the right to decide on the extradition of its nationals on the basis of reciprocity and to refuse their extradition on the grounds of public morality, public policy and State security.

Extradition shall be granted only under the condition that any person, national, stateless person or alien suspected of having committed a crime will not be tried in a special court of the requesting Party or that his or her extradition is not requested to carry out a sentence or detention order issued by such court.

Georgia reserves the right to refuse the extradition of any person on humanitarian grounds, if the extradition would adversely affect the state of this person.

Note-

On 31 January 2002, the Secretary-General of the Council of Europe, as depositary, received a withdrawal of reservation contained in a Note verbale from the Ministry of Foreign Affairs of *Israel*:

Following the 2001 Amendment of its Extradition Law (1954), Israel informs the Secretary General of the withdrawal of one of the two reservations made to Article 2 of the European Convention on Extradition. The 2001 Amendment of the Extradition Law (1954) extended the definition of "extraditable offences" to render every offence punishable by "one or more years imprisonment" an extraditable offence. Previously, only offences punishable by more than three years imprisonment were considered extraditable unless they were included in a specific list of extraditable offences, which was included in the reservation Israel is withdrawing. The new definition allows for a greater flexibility in extradition.

After this withdrawal only one reservation to Article 2 will remain. This reservation reads as follows:

"Israel will not grant extradition of a person charged with an offence unless it is proved in a court in Israel that there is evidence which would be sufficient for committing him to trial for such an offence in Israel."

The Ministry wishes to point out that Israel's other reservations are to remain in force.

Withdrawal Reservation:

On 28 September 2001, the Secretariat-General of the Council of Europe, as depositary, received from the Government of Sweden a letter dated 24 September, as follows:

Sweden withdraws its reservation on Article 2 of the European Convention on Extradition, made in connection with the deposit of its instrument of ratification on 22 January 1959 and amended on 14 April 1967

In accordance with article 23 of the Argentine Constitution, "in the event of internal unrest or external attack which poses a threat to the functioning of this Constitution and the authorities created thereunder, a state of siege shall be declared in the province or territory in which the public disturbance exists and constitutional guarantees shall be suspended therein. However, during such suspension the President of the Republic shall not have the power to convict or punish. In such event, his powers with respect to persons shall be limited to arresting or transferring them within the country, unless they prefer to leave Argentine territory".

The serious acts of collective violence which had taken place in Argentina had caused damage and endangered the lives and property of the inhabitants of the Republic to a degree that amounted to a state of internal unrest. This made it essential to take the above-mentioned emergency measure, which lasted for the time strictly necessary to guarantee an end to the emergency situation, in order to safeguard the free exercise of citizens' rights.

By Decree No. 1689/2001 of 21 December 2001, the President of the Argentine Republic, Mr. Fernando de la Rúa, ordered the lifting of the state of siege declared by Decree No. 1678/2001.

This measure is justified by the exceptional circumstances prevailing in some regions in the Sudan which represent a serious threat to the security and stability of the country and the people.

While derogating itself from certain obligations in the International Covenant on Civil and Political Rights, to the extent strictly required by the exigencies of the situation, the Government of the Republic of the Sudan would like to assure that such measures will not be inconsistent with its obligations under international law and do not involve discrimination solely on the base of race, colour, sex or social origin. These basic rights are embodied in, and protected by, part 2 of the constitution of the Sudan.

The extension of the state of emergency will not affect the basic rights referred to in articles 6, 7, 8, 11, 15, 16 and 18 of the Covenant

In compliance with article 4 (paragraph 3) of the International Covenant on Civil and Political Rights, the Government of the Republic of the Sudan hereby requests the Secretary-General of the United Nations to circulate this communication to all States Parties to the Covenant.

On 20 December 2001, the Secretary-General of the United Nations, as depositary, received from the Government of *Italy* a Communication relating to the Reservations made by Botswana upon Signature and Confirmed upon Ratification¹, as follows;

The Government of the Italian Republic has examined the reservations made by the Republic of Botswana upon signature of the International Covenant on Civil and Political Rights, and confirmed upon ratification, regarding articles 7 and 12, paragraph 3 of the Covenant.

The Government of the Italian Republic notes that the aforesaid articles of the Covenant are being made subject to a general reservation referring to the content of existing legislation in Botswana. The Government of the Italian Republic is of the view that, in the absence of further clarification, these reservations referring to international legislation raise doubts as to the commitment of Botswana to fulfill its obligation under the Covenant.

The Government of the Italian Republic considers these reservations to be incompatible with the object and purpose of the Covenant according to article 19 of the 1969 Vienna Convention on the law of treaties. These reservations do not fall within the rule of article 20, paragraph 5, and can be objected to at any time.

Therefore the Italian Government objects to the aforesaid reservations made by the Republic of Botswana to the Covenant.

This objection does not preclude the entry into force of the Convention between Italy and Botswana.

The Government of Austria considers that, in the absence of further clarification, this reservation raises doubts as to the degree of commitment assumed by Mauritania in becoming a party to the Convention since it refers to the contents of Islamic Sharia and to existing national legislation in Mauritania. The Government of Austria would like to recall that, according to art. 28(2) of the Convention as well as customary international law as codified in the Vienna Convention on the Law of Treaties, a reservation incompatible with the object and purpose of a treaty shall not be permitted. It is in the common interest of States that treaties to which they have chosen to become parties are respected as to their object and purpose, by all parties, and that States are prepared to undertake any legislative changes necessary to comply with their obligations under the treaties.

For these reasons, the Government of Austria objects to this reservation made by the Government of Mauritania.

This position, however, does not preclude the entry into force in its entirety of the Convention between Mauritania and Austria.

On 4 March 2002, the Secretary-General of the United Nations, as depositary, received from the Government of *France* the following Objection;

Having considered the reservations and declarations made on 27 February 2001 by the Democratic People's Republic of Korea to the Convention on the Elimination of All Forms of Discrimination against Women of 18 December 1979, the Government of the French Republic objects to the said reservations and declarations relating to article 2, paragraph (f) and article 9, paragraph 2.

On 2 October 2002, the Secretary-General of the United Nations, as depositary, received from the Government of *Ireland* and the following Objection;

As to the former of the aforesaid reservations, the Government of Ireland is of the view that a reservation which consists of a general reference to religious law without specifying the content thereof and which does not clearly specify the provisions of the Convention to which it applies and the extent of the derogation therefrom, may cast doubts on the commitment of the reserving State to fulfil its obligations under the Convention. The Government of Ireland is furthermore of the view that such a general reservation may undermine the basis of international treaty law.

As to the reservation to Article 9, paragraph 2 of the Convention, the Government of Ireland considers that such a reservation aims to exclude one obligation of non-discrimination which is so important in the context of the Convention on the Elimination of All Forms of Discrimination Against Women as to render this reservation contrary to the essence of the Convention. The Government of Ireland notes in this connection that Article 28, paragraph 2 of the Convention provides that a reservation incompatible with the object and purpose of the Convention shall not be permitted.

The Government of Ireland moreover recalls that by ratifying the Convention, a State commits itself to adopt the measures required for the elimination of discrimination, in all its forms and manifestations, against women.

The Government of Ireland therefore objects to the aforesaid reservations made by the Government of the Kingdom of Saudi Arabia to the Convention on the Elimination of All Forms of Discrimination Against Women.

This objection shall not preclude the entry into force of the Convention between Ireland and the Kingdom of Saudi Arabia."

On 8 February 2002, the Secretary-General of the United Nations, as depositary, received from the Government of the Netherlands the following Objection:

"The Government of the Kingdom of the Netherlands has examined the reservation made by the Government of Mauritania at the time of its accession to the Convention on the Elimination of All Forms of Discrimination against Women and considers that the reservation concerning the Islamic Sharia and the national law of Mauritania, which seeks to limit the responsibilities of the reserving State under the Convention by invoking the Sharia and national law, may raise doubts as to the commitment of this State to the object and purpose of the Convention and, moreover, contribute to undermining the basis of international treaty law. The Government of the Kingdom of the Netherlands recalls that, according to paragraph 2 of Article 28 of the Convention, a reservation incompatible with the object and purpose of the Convention shall not be permitted.

It is in the common interest of States that treaties to which they have chosen to become party are respected, as to their object and purpose, by all parties and that States are prepared to undertake any legislative changes necessary to comply with their obligations under the treaties. The Government of the Kingdom of the Netherlands therefore objects to the aforesaid reservation made by the Government of Mauritania to the Convention on the Elimination of All Forms of Discrimination against Women.

This objection shall not preclude the entry into force of the Convention between the Kingdom of the Netherlands and Mauritania."

On 21 January 2002, the Secretary-General of the United Nations, as depositary, received from the Government of Sweden the following Objection:

This objection shall not preclude the entry into force of the Convention between the United Kingdom of Great Britain and Northern Ireland and Mauritania."

On 8 March 2002, the Secretary-General of the International Maritime Organisation, as depositary, received a communication from the Government of the Kingdom of Sweden in accordance with resolution A.924(220, article 15 of the above Convention, as follows:

Re Swedish Implementation of the Convention for the Suppression of Unlawful Acts against the Safety of Maritime Navigation and the Protocol for the Suppression of Unlawful Acts against the Safety of Fixed Platforms Located on the Continental Shelf

According to the records of statistics available to the Ministry of Justice, there have been no criminal proceedings before a court of law in Sweden with respect to any of the offences set out in article 3 of the 1988 Rome Convention after its entry into force for Sweden¹.

To implement the Convention and its Protocol changes in Chapter 13 Section 5 a in the Swedish Penal Code were needed. The provisions in this section of the Penal Code—concerning hijacking—were adjusted to meet the obligations set forth in the agreements. In all other aspects, existing provisions in Swedish law were considered to be in compliance with the requirements in the instruments. Sweden applies universal jurisdiction when it comes to the crimes in question (Chapter 2 Section 3 of the Penal Code).

¹ The Organisation may wish to note that in 1987 the Swedish Supreme Court tried a case where a mate of a foreign ship had been indicted for offences covered, at least partially, by the subsequent 1988 Rome Convention. The mate was accused of having—armed with a gun—seized the ship and sailed it to a port in Sweden. The objective of the mate was to seek for asylum in Sweden. During the voyage the other members of the crew were kept in closed spaces of the ship. The Supreme Court convicted the mate of unlawful deprivation of liberty, unlawful dispossession of the ship and of unlawful possession of weapon. The mate was given a conditional sentence.

#### The Swedish Penal Code

#### Chapter 2-On the Applicability of Swedish Law

#### Section 3

Even in cases other than those listed in Section 2, crimes committed outside the Realm shall be adjudged according to Swedish law and by a Swedish court:

- 1. if the crime was committed on board a Swedish vessel or aircraft or was committed in the course of duty by officer in charge or a member of its crew.
- 2. if the crime was committed by a member of the armed forces in an area in which a detachment of the armed forces was present, or if it was committed by some other person in such an area and the detachment was present for a purpose other than an exercise.
- 3. if the crime was committed in the course of duty outside the Realm by a person employed in a foreign contingent of the Swedish armed forces,

Cuba is therefore firmly of the opinion that the undue use of the armed forces of one State for the purpose of aggression against another cannot be condoned under the present Convention, whose purpose is precisely to combat, in accordance with the principles of the international law, one of the most noxious forms of crime faced by the modern world.

To condone acts of aggression would amount, in fact, to condoning violations of international law and of the Charter and provoking conflicts with unforeseeable consequences that would undermine the necessary cohesion of the international community in the fight against the scourges that truly afflict it.

The Republic of Cuba also interprets the provisions of the present Convention as applying with full rigour to activities carried out by armed forces of one State against another State in cases in which no armed conflict exists between the two.

## Declaration**
