Your Excellency,

I have the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Swiss Federal Council for air services between and beyond their respective territories, done at London on 5 April 1950¹, as amended, (the "Agreement") and to discussions which have recently taken place between representatives of the two Governments.

As a result of these discussions, I have the honour to propose that the Agreement shall be amended by substituting the word "airport" for the word "city" in the Note to Schedules I and II of the Annex which currently provides that "any city pair may be served on route 1 of the relevant Schedule by up to two designated airlines of each Contracting Party".

If the foregoing proposal is acceptable to the Swiss Federal Council, I have the honour to suggest that this Note and Your Excellency's reply to that effect shall, in accordance with Article 9 of the Agreement, constitute an Agreement between our two Governments which shall enter into force on the date of your reply.

I avail myself of this opportunity to renew to Your Excellency the assurance of my highest consideration.
