## AMENDMENT

## TO THE STATUTE OF THE COUNCIL OF EUROPE CERTIFICATE OF THE SECRETARY GENERAL

(Article 41, Paragraph d, of the Statute)

Certificate of the Secretary General of the Council of Europe
Whereas paragraph d of Article 41 of the Statute of the Council of Europe provides that amendments to Articles 23-35, 38 and 39 which have been approved by the Committee of Ministers and the Consultative Assembly shall come into force on the date of the certificate of the Secretary General, transmitted to the governments of members, certifying that they have been so approved,

The Secretary General hereby certifies as follows:

1. The Committee of Ministers, by the adoption on 30 June 1993 of Resolutions (93) 32 and (93) 33, fixing respectively the number of Representatives of the Czech Republic and of the Slovak Republic in the Consultative Assembly, approved the amendments to Article 26 of the Statute, the text of which is set out below;
2. The Consultative Assembly approved the same amendments on 29 June 1993 (Opinions Nos. 174 and 175 (1993));
3. Both organs of the Council of Europe having thus approved them, the amendments come into force this 30th day of June 1993, being the date of this certificate, transmitted on the same date to the governments of members.

The amended text of Article 26 is worded as follows:
" Members shall be entitled to the number of Representatives given below:
