# EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF INDIA FURTHER AMENDING THE AIR SERVICES AGREEMENT, DONE AT NEW DELHI. 1 DECEMBER 1951

The United Kingdom High Commissioner at New Delhi to the Secretary, Department of Civil Aviation of the Government of India

Sir,

I have the honour to refer to the Air Services Agreement between the Government of India and the Government of the United Kingdom of Great Britain and Northern Ireland signed at New Delhi on 1 December,  $1951^1$ , as amended (hereinafter called "the Agreement"), and to the discussions between official delegations which took place in New Delhi on 9–11 February, 1993 to review the route schedules annexed to the Agreement.

In accordance with the decisions arrived at in those discussions, the Government of the United Kingdom and Northern Ireland propose that the Agreement should be further amended by substituting for Schedules I and II thereof the Schedules I and II annexed to this Note.

If the above proposal is acceptable to the Government of India, I propose that this Note and your reply to that effect shall be regarded as constituting an Agreement between the two Governments in this matter, which shall enter into force on today's date.

Please accept, Sir the assurances of my highest consideration.

### Route Schedule for UK Designated Airlines

#### Note:

(1) All services must originate/terminate in United Kingdom on Route I and Hong Kong on Route II. Subject to this, any point or points on the Routes may be omitted.

(2) Points other than those specified above in columns 3 and 5 may be served without traffic rights between such points and points in column 4.

(3) The phrase "One or more as desired" in columns 3 and 5 means that the United Kingdom designated airlines may serve one or more of the points on the same flight and different points may be served on different flights.

(4) The ability to serve two points on the same flight will be mutually determined by the two aeronautical authorities.

## Route Schedule for the Indian Designated Airlines

Note:

(1) All services must originate/terminate in India. Subject to this, any point or points on the routes may be omitted.

(2) Points other than those specified above in columns 3 and 5 may be served without traffic rights between such points and points in column 4.

(3) The phrase "One or more as desired" in columns 3 and 5 means that the Indian designated airlines may serve one or more of the points on the same flight and different points may be served on different flights.

(4) The ability to serve two points on the same flight will be mutually determined by the two aeronautical authorities.

(5) Only one point in the USA may be served on each flight.
