# EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE REPUBLIC OF NICARAGUA CONCERNING THE UNITED KINGDOM/NICARAGUA RETROSPECTIVE TERMS ADJUSTMENT AGREEMENT 1994

#### Her Majesty's Ambassador at Managua to the Minister of Foreign Cooperation of the Republic of Nicaragua

British Embassy Managua 15 March 1995

Your Excellency,

I have the honour to inform you that with reference to the recent discussions between our Governments, that it is the intention of the Government of the United Kingdom of Great Britain and Northern Ireland (hereinafter referred to as the Government of the United Kingdom) to provide assistance to the Government of Nicaragua, as recommended by the Trade and Development Board (TDB) of UNCTAD, in the form of adjustment to the terms of the following agreements:

United Kingdom/Nicaragua Loan No. 1 1974<sup>1</sup>. (hereinafter referred to as "the 1974 Loan")

United Kingdom/Nicaragua Debt Rescheduling Agreement 1992<sup>2</sup>. (hereinafter referred to as "the 1992 Agreement").

The amounts and due dates of the payments due under the above agreements are set out in the Annex to this Note.

Save to the extent to which the Government of the United Kingdom notifies the Government of Nicaragua otherwise in writing the Government of the United Kingdom shall waive all payments of arrears due under the 1974 Loan up to and including 30 October, 1994 (as set out in the Annex to this Note). Save to the extent to which the Government of the United Kingdom notifies the Government of Nicaragua otherwise in writing the Government of the United Kingdom shall waive all payments due under the 1994 Loan and the 1992 Agreement on or after 14 October, 1994 (as set out in the Annex to this Note) shall be waived as from the date that such payments fall due.

If the foregoing proposals are acceptable to the Government of Nicaragua I have the honour to propose that the present Note, together with its Annex, and Your Excellency's reply in that sense shall constitute an Agreement between the Government of the United Kingdom and the Government of Nicaragua which shall enter into force on the date of Your Excellency's reply, and which shall be known as the "United Kingdom/Nicaragua Retrospective Terms Adjustment Agreement 1994".

I avail myself of this opportunity to renew to Your Excellency the assurances of my highest consideration.
