Her Britannic Majesty's Embassy present their compliments to the Ministry of Foreign Affairs of Ukraine and have the honour to refer to the Exchange of Notes between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Union of Soviet Socialist Republics concerning the Mutual Abolition of Consular Fees on Visas signed in Moscow of 13 April 1964.

It is proposed that, notwithstanding paragraph 2(c) of the said Exchange of Notes, the agreement constituted by the said Exchange of Notes be terminated as between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of Ukraine on 30 November 1995.

If the above is acceptable to the Government of Ukraine it is proposed that this Note and the Ukrainian Government reply shall constitute an agreement between our two Governments in this matter, which shall enter into force on the date of the Ukrainian Government reply.

Her Britannic Majesty's Embassy avail themselves of the opportunity to renew to the Ministry of Foreign Affairs of Ukraine the assurances in their highest consideration.

The Ministry of Foreign Affairs of Ukraine present their compliments to Her Britannic Majesty's Embassy in Ukraine and referring to the Embassy Note No. 144/95 from 13 October 1995 have the honour to inform them of the decision of the Ukrainian Government taken on 8 February 1996 on termination of the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the government of the Union of Soviet Socialist Republics concerning the Mutual Abolition of Consular Fees on Visas signed of 13 April 1964.

Taken the above into account the above mentioned Embassy Note and this Note constitute an Agreement between the government of the United Kingdom of Great Britain and Northern Ireland and the Government of Ukraine on this issue.
