AMENDMENT TO THE AGREEMENT BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE UNITED STATES OF AMERICA FOR COOPERATION ON THE USES OF ATOMIC ENERGY FOR MUTUAL DEFENCE PURPOSES

The Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the United States of America;

Desiring to amend in certain respects the Agreement for Cooperation on the Uses of Atomic Energy for Mutual Defence Purposes, signed at Washington on the third day of July, 1958¹, as amended (herein referred to as the "Agreement");

Have agreed as follows:

ARTICLE 1

Article III bis of the Agreement is amended by:

(a) substituting "2014" for 2004" throughout the Article.

ARTICLE 2

This Amendment shall enter into force on the date on which each Government shall have received from the other Government written notification that it has complied with all statutory and constitutional requirements for the entry into force of this Amendment.
