# The Foreign and Commonwealth Office to the Embassy of the Russian Federation in London

The Foreign and Commonwealth Office presents its compliments to the Embassy of the Russian Federation and has the honour to refer to the Embassy's Note No.15 of 1 March 2006 regarding the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Russian Federation on Science and Technology Cooperation, done at Moscow on 28 May 1996 ("the 1996 Agreement").

The Foreign and Commonwealth Office has the honour to inform the Government of the Russian Federation that the Government of the United Kingdom of Great Britain and Northern Ireland can accept its proposal to extend the 1996 Agreement for a period of ten years from 28 May 2006 in accordance with Article 11(1) of the 1996 Agreement with the following amendment:

Article 9(2) of the 1996 Agreement shall be replaced by the following:

The Joint Committee shall meet once every two years alternately in the United Kingdom of Great Britain and Northern Ireland and in the Russian Federation unless otherwise agreed.

If this proposal is acceptable to the Government of the Russian Federation, the Foreign and Commonwealth Office propose that this Note, and the Embassy's reply, shall constitute an Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Russian Federation, in accordance with the Article 11(1) of the 1996 Agreement, which shall enter into force on the date of the Embassy's reply.

The Foreign and Commonwealth Office avails itself of this opportunity to renew to the Embassy the assurances of its highest consideration.
