# EXCHANGE OF NOTES AMENDING THE AGREEMENT BETWEEN THE GOVERNMENT OF THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE GOVERNMENT OF THE REPUBLIC OF FINLAND CONCERNING THE MUTUAL PROTECTION OF CLASSIFIED INFORMATION

#### No. 1

From the British Embassy in Helsinki to the Ministry of Foreign Affairs of Finland

21 March 2014

Her Britannic Majesty's Embassy presents its compliments to the Ministry of Foreign Affairs of the Republic of Finland and has the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Finland concerning the Mutual Protection of Classified Information, done at London on 7 June 2012 and to recent discussions between officials of our two Governments concerning the desirability of amending the aforesaid Agreement because of changes to the United Kingdom Classification System which are due to come into effect on 2 April 2014.

In accordance with the amendment procedures of Article 14(2) of the Agreement, the Government of the United Kingdom of Great Britain and Northern Ireland has the honour to propose that the Agreement be amended as follows:

- (1) Article 4 shall be amended as follows:
- (a) the table of equivalences referred to in paragraph 2 shall be replaced by the following:

- (b) the following new paragraph 3 shall be added:
- "3. The UK will afford LUOTTAMUKSELLINEN Classified Information an equivalent level of protection as it would for UK SECRET."
- (c) paragraphs 3 and 4 shall be renumbered 4 and 5 respectively.
- (2) Article 5 shall be amended as follows:

- (a) in paragraph 6, line 2, the word "RESTRICTED" shall be replaced by "OFFICIAL—SENSITIVE"
- (3) Article 6 shall be amended as follows:
- (a) in paragraph 1, line 2, the word "CONFIDENTIAL" shall be replaced by "SECRET"
- (b) in paragraph 2, line 1, the word "CONFIDENTIAL" shall be replaced by "SECRET"
- (c) in paragraph 4, line 2, the word "RESTRICTED" shall be replaced by "OFFICIAL-SENSITIVE"
- (4) Article 7 shall be amended as follows:
- (a) in paragraph 1, line 1, the word "CONFIDENTIAL" shall be replaced by "SECRET"
- (b) in paragraph 3, line 1, the word "RESTRICTED" shall be replaced by "OFFICIAL—SENSITIVE"
- (5) Article 8 shall be amended as follows:
- (a) in paragraph 3, line 2,the word "the" shall be added between the words "with national"
- (b) in paragraph 3, line 2,the words "of the Recipient" shall be added between the words "regulations when"
- (6) Article 9 shall be amended as follows:
- (a) in paragraph 1, line 1, the word "CONFIDENTIAL" shall be replaced by "SECRET"
- (b) in paragraph 4, line 1, the word "RESTRICTED" shall be replaced by "OFFICIAL-

#### SENSITIVE"

If the foregoing proposal is acceptable to the Government of the Republic of Finland, the British Embassy has the honour to propose that this Note and the Ministry's reply shall constitute an agreement amending the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Finland which shall enter into force on the date of the reply and shall apply on the 2 April 2014.

The Embassy avails itself of this opportunity to renew to the Honourable Ministry of Foreign Affairs of the Republic of Finland the assurance of its highest consideration.

- (a) in paragraph 6, line 2, the word "RESTRICTED" shall be replaced by "OFFICIAL-SENSITIVE"
- (3) Article 6 shall be amended as follows:
- (a) in paragraph 1, line 2, the word "CONFIDENTIAL" shall be replaced by "SECRET"
- (b) in paragraph 2, line 1, the word "CONFIDENTIAL" shall be replaced by "SECRET"

- (c) in paragraph 4, line 2, the word "RESTRICTED" shall be replaced by "OFFICIAL-SENSITIVE"
- (4) Article 7 shall be amended as follows:
- (a) in paragraph 1, line 1, the word "CONFIDENTIAL" shall be replaced by "SECRET"
- (b) in paragraph 3, line 1, the word "RESTRICTED" shall be replaced by "OFFICIAL-

- (5) Article 8 shall be amended as follows:
- (a) in paragraph 3, line 2,the word "the" shall be added between the words "with national"
- (b) in paragraph 3, line 2,the words "of the Recipient" shall be added between the words
- "regulations when"
- (6) Article 9 shall be amended as follows:
- (a) in paragraph 1, line 1, the word "CONFIDENTIAL" shall be replaced by "SECRET"
- (b) in paragraph 4, line 1, the word "RESTRICTED" shall be replaced by "OFFICIAL-

The Ministry for Foreign Affairs of the Republic of Finland have the honour to inform the Embassy that the forgoing is acceptable to the Government of the Republic of Finland and that the British Embassy's Note and this Note in reply from the Ministry for Foreign Affairs on behalf of the Government of the Republic of Finland shall constitute an agreement amending the Agreement between the Government of the Republic of Finland and the Government of the United Kingdom of Great Britain and Northern Ireland concerning the Mutual Protection of Classified Information which shall enter into force on the date of the reply and shall apply from 2 April 2014.
