The Welsh Ministers, being the traffic authority for the relevant length of the Maentwrog – East of Conwy Trunk Road (A470) (hereinafter referred to as "the trunk road"), are satisfied that traffic in a specified length of the trunk road should be restricted or prohibited by reason of works being executed thereon.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

**1.** This Order comes into force on 6 June 2011 and its title is The A470 Trunk Road (Dolwyddelan, Conwy County Borough) (Temporary Traffic Restrictions & Prohibition) Order 2011.

### **2.**—(1) In this Order:

"the length of the trunk road" ("y darn o'r gefnffordd") means that length of the A470 trunk road at Dolwyddelan in the County Borough of Conwy which extends from the termination of the 30 mph speed limit zone at the eastern end of Dolwyddelan to the centre-point of the road junction known as Tanaeldroch;

"works period" ("cyfnod y gwaith") means the period commencing at 09:00 hours on 6 June 2011 and ending when the temporary traffic signs are removed.

- (2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.
- **3.** Subject to the provisions of article 6, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road.
- **4.** Subject to the provisions of article 6, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.
- **5.** Subject to the provisions of article 6, no person shall, during the works period, use or permit the use of a vehicle in such a way that it overtakes any other vehicle in the length of the trunk road during such times as the restriction referred to in article 4 is in operation.
- **6.** The provisions of articles 3, 4 and 5 apply only during such times and to such extent as the application of the restrictions and prohibition referred to therein is indicated by traffic signs.
- 7. The maximum duration of this Order shall be 6 months.
