**ROAD TRAFFIC, WALES**

The A470 Trunk Road (Carno,  
Powys) (Temporary Traffic  
Restrictions & Prohibitions) Order  
2011

*Made* *23 November 2011*

*Coming into force* *5 December 2011*

The Welsh Ministers, being the traffic authority for the relevant length of the Caersws – Machynlleth Trunk Road (A470) (hereinafter referred to as “the trunk road”), are satisfied that traffic in a specified length of the trunk road should be restricted or prohibited by reason of works being executed thereon.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

1. This Order comes into force on 5 December 2011 and its title is The A470 Trunk Road (Carno, Powys) (Temporary Traffic Restrictions & Prohibitions) Order 2011.

2. —(1) In this Order:

“exempted vehicle” (*“cerbyd esempt”*) means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

“the length of the trunk road” (*“y darn o’r gefnffordd”*) means the length of the A470 trunk road at Carno in the County of Powys that extends from the centre-point of its junction with the U4604 (Gerddi Cledan) to the centre-point of its junction with the U4601 to Tanllyn;

“works period” (*“cyfnod y gwaith”*) means the period commencing at 08:00 hours on 5 December 2011 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

3. Subject to the provisions of article 8, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road.

4. Subject to the provisions of article 8, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour in the length of the trunk road.

5. Subject to the provisions of article 8, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.

6. Subject to the provisions of article 8, no person shall, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle in the length of the trunk road during such times as the restriction referred to in article 5 is in operation.

7. Subject to the provisions of article 8, no person shall, during the works period, drive or cause or permit any vehicle with a width greater than 2.5 metres, other than an exempted vehicle, to proceed in the length of the trunk road.

8. The provisions of articles 3, 4, 5, 6 and 7 apply only during such times and to such extent as the application of the restrictions and prohibitions referred to therein is indicated by traffic signs.

9. The maximum duration of this Order shall be 6 months.
