The A470 Trunk Road (Southbound Carriageway between Abercynon Roundabout and Broadway Interchange, Rhondda Cynon Taf) (Temporary Prohibition of Vehicles) Order 2011

The Welsh Ministers, as the traffic authority for the Cardiff – Llangurig Trunk Road (A470) (hereinafter referred to as "the trunk road"), are satisfied that traffic in specified lengths of the trunk road should be prohibited by reason of works proposed to be executed thereon.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

1. This Order comes into force on 1 March 2011 and its title is The A470 Trunk Road (Southbound Carriageway between Abercynon Roundabout and Broadway Interchange, Rhondda Cynon Taf) (Temporary Prohibition of Vehicles) Order 2011.

2.—1) In this Order:

"exempted vehicle" ("cerbyd esempt") means any vehicle being used for or in connection with the works giving rise to this Order or by the emergency services;

"the lengths of the trunk road" ("y darnau o'r gefnffordd") means:

i. that length of the southbound carriageway of the A470 trunk road which extends from the give way markings of the southbound on slip road at Abercynon Roundabout to the give way markings of the southbound off slip road at Broadway Roundabout;

ii. the length of the southbound entry slip road situated south of Ty Trevithick, Pontypridd, which extends from the exit from the A4054 to its merge with the main southbound carriageway of the trunk road;

"works period" ("cyfnod y gwaith") means that period commencing at 20:00 hours on 1 March 2011 and ending when the temporary traffic signs have been permanently removed.

- (2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.
- **3.** Subject to the provisions of article 4, no person shall, during the works period, drive any vehicle or cause or permit any vehicle, other than an exempted vehicle, to proceed in the lengths of the trunk road.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as the application of the prohibition referred to therein is indicated by traffic signs.
- **5.** The maximum duration for this Order shall be 12 months.
