The A40 Trunk Road (West of Carmarthen, Carmarthenshire) (Temporary Traffic Restrictions & Prohibition) Order 2011

24 February 2011

Coming into force

1 March 2011

The Welsh Ministers, being the traffic authority for the relevant length of the London – Fishguard Trunk Road (A40) (hereinafter referred to as "the trunk road"), are satisfied that traffic in a specified length of the trunk road should be restricted or prohibited by reason of works being executed thereon.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

1. This Order comes into force on 1 March 2011 and its title is The A40 Trunk Road (West of Carmarthen, Carmarthenshire) (Temporary Traffic Restrictions & Prohibition) Order 2011.

2.—(1) In this Order:

"the length of the trunk road" ("y darn o'r gefnffordd") means that length of the A40 trunk road to the west of Carmarthen in the County of Carmarthenshire which extends from a point 35 metres west of the centre of its junction with the U2121 to a point 4711 metres west of the centre of the said junction;

"works period" ("cyfnod y gwaith") means the period commencing at 00:01 hours on 1 March 2011 and ending when the temporary traffic signs are removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

- **3.** Subject to the provisions of article 6, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road.
- **4.** Subject to the provisions of article 6, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.
- **5.** Subject to the provisions of article 6, no person shall, during the works period, use or permit the use of a vehicle in such a way that it overtakes any other vehicle in the length of the trunk road during such times as the restriction referred to in article 4 is in operation.
- **6.** The provisions of articles 3, 4 and 5 apply only during such times and to such extent as the application of the restrictions and prohibition referred to therein is indicated by traffic signs.
- 7. The maximum duration of this Order shall be 12 months.
