## **ROAD TRAFFIC, WALES**

The A470 Trunk Road (Slip Roads at Taffs Well and Upper Boat Interchanges, Rhondda Cynon Taf) (Temporary Prohibition of Vehicles) Order 2011

Made 2 March 2011

Coming into force 14 March 2011

The Welsh Ministers, being the traffic authority for the relevant lengths of the Cardiff – Llangurig Trunk Road (A470) (hereinafter referred to as "the trunk road"), are satisfied that traffic in specified lengths of the trunk road should be prohibited by reason of works proposed to be executed thereon.

The Welsh Ministers, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

1. This Order comes into force on 14 March 2011. The title to this Order is The A470 Trunk Road (Slip Roads at Taffs Well and Upper Boat Interchanges, Rhondda Cynon Taf) (Temporary Prohibition of Vehicles) Order 2011.

### 2.—1) In this Order:

"the lengths of the trunk road" ("y darnau o'r gefnffordd") means the lengths of the A470 trunk road at Taffs Well and Upper Boat Interchanges in the County Borough of Rhondda Cynon Taf described in the Schedule to this Order;

"works period," ("cyfnod y gwaith") means that period commencing at 21.00 hours on 14 March 2011 and ending when the temporary traffic signs are permanently removed;

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services and in connection with the works giving rise to this Order.

- (2) Any reference in this Order to a numbered article or Schedule is a reference to the article or Schedule bearing that number in this Order.
- **3.** Subject to the provisions of article 4, no person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed along the lengths of the trunk road specified in the Schedule.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as the application of the prohibition referred to therein is indicated by traffic signs.
- **5.** The maximum duration for this Order shall be 18 months.
