**ROAD TRAFFIC, WALES**

**The A55 Trunk Road (Britannia  
Bridge, Gwynedd and Isle of  
Anglesey) (Temporary Traffic  
Restrictions & Prohibitions) Order  
2011**

*Made* 17 January 2011

*Coming into force* 24 January 2011

The Welsh Ministers, being the traffic authority for the relevant length of the Chester - Bangor Trunk Road (A55) (hereinafter referred to as “the trunk road”), are satisfied that traffic in a specified length of the trunk road should be restricted or prohibited by reason of works being executed thereon.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

1. This Order comes into force on 24 January 2011 and its title is The A55 Trunk Road (Britannia Bridge, Gwynedd and Isle of Anglesey) (Temporary Traffic Restrictions & Prohibitions) Order 2011.

2. —(1) In this Order:

“the length of the trunk road” (“*y darn o’r gefnffordd*”) means that length of the A55 trunk road in the Counties of Gwynedd and the Isle of Anglesey that extends from Junction 8 to Junction 9;

“works period” (“*cyfnod y gwaith*”) means the period commencing at 01:00 hours on 24 January 2011 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

3. Subject to the provisions of article 8, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour in the length of the trunk road.

4. Subject to the provisions of article 8, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.

5. Subject to the provisions of article 8, no person shall, during the works period, drive or cause or permit any vehicle to overtake in the length of the trunk road during such times as the restriction referred to in article 4 is in operation.

6. Subject to the provisions of article 8, no person shall, during the works period, ride or cause to be ridden any pedal cycle in the length of the trunk road.

7. The provisions of The Trunk Road (A5) (Llanfairpwllgwyngyll, Gwynedd) (50 mph Speed Limit) Order 1983(3) are hereby suspended during such times as the restrictions specified in articles 3 and 4 are in operation.

8. The provisions of articles 3, 4, 5, 6 and 7 apply only during such times and to such extent as the application of the restrictions and prohibitions referred to therein is indicated by traffic signs.

9. The maximum duration of this Order shall be 6 months.
