# **ROAD TRAFFIC, WALES**

The A494/A550 Trunk Road (Deeside Interchange, Flintshire) (Temporary Prohibition of Vehicles) Order 2012

Made

25 June 2012

### Coming into force 5 July 2012

The Welsh Ministers, being the traffic authority for the relevant lengths of the Dolgellau – South of Birkenhead Trunk Road (A494/A550) (hereinafter referred to as "the trunk road"), are satisfied that traffic in specified lengths of the trunk road should be prohibited by reason of proposed road works.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

**1.** This Order comes into force on the 5 July 2012 and its title is The A494/A550 Trunk Road (Deeside Interchange, Flintshire) (Temporary Prohibition of Vehicles) Order 2012.

**2.**—(1) In this Order:

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

"the lengths of the trunk road" ("y darnau o'r cefnffordd") means the lengths of the A494/A550 trunk road at Deeside Interchange in the County of Flintshire specified in the Schedule to this Order;

"works period" ("*cyfnod y gwaith*") means that period commencing at 22:00 hours on 5 July 2012 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article or Schedule is a reference to the article or Schedule bearing that number in this Order.

**3.** Subject to the provisions of article 4, no person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed in the lengths of the trunk road specified in the Schedule.

**4.** The provisions of article 3 shall apply only at such times and to such extent as traffic signs indicate the application of the prohibition referred to therein.

#### **SCHEDULE**

i) The entire length of the northbound off slip road of A494 trunk road which links with the main northbound carriageway of the A550 trunk road at Deeside Interchange.

ii) That length of the northbound on slip road of the A550 trunk road that extends northwards from a point at its junction with the roundabout at Deeside Park Interchange (A548) for a distance of 341 metres.
