The A40 Trunk Road
(Haverfordwest, Pembrokeshire)
(Temporary Traffic Restrictions &
Prohibition) Order 2012

Made *20 September 2012*

Coming into force *1 October 2012*

The Welsh Ministers, being the traffic authority for the relevant length of the London - Fishguard Trunk Road (A40) (hereinafter referred to as “the trunk road”), are satisfied that traffic in a specified length of the trunk road should be restricted or prohibited by reason of works being executed thereon.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 1 October 2012 and its title is The A40 Trunk Road (Haverfordwest, Pembrokeshire) (Temporary Traffic Restrictions & Prohibition) Order 2012.

2. —(1) In this Order:

“exempted vehicle” (*“cerbyd esempt”*) means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

“the length of the trunk road” (*“y darn o’r gefnffordd”*) means the length of the A40 trunk road at Haverfordwest in the County of Pembrokeshire that extends from a point 100 metres east of Withybush Roundabout to a point 35 metres south of the centre-point of its junction with Clarbeston Road;

“works period” (*“cyfnod y gwaith”*) means the period commencing at 00:01 hours on 1 October 2012

and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Restrictions & Prohibition

3. Subject to the provisions of article 7, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road.

4. Subject to the provisions of article 7, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.

5. Subject to the provisions of article 7, no person shall, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle in the length of the trunk road during such times as the restriction referred to in article 4 is in operation.

Suspension

6. The provisions of The A40 Trunk Road (Withybush, Haverfordwest, Pembrokeshire) (40 mph and 50 mph Speed Limits) Order 2006(3) insofar as they apply to the length of the trunk road specified in article 2(1) are hereby suspended during such times as the restrictions specified in articles 3 and 4 are in operation.

Application

7. The provisions of articles 3, 4 and 5 apply only during such times and to such extent as the application of the restrictions and prohibition referred to therein is indicated by traffic signs.

Duration of this Order

8. The maximum duration of this Order shall be 18 months.
