**ROAD TRAFFIC, WALES**

The A458 Trunk Road (Nant yr  
Ehedydd, Mallwyd, Gwynedd)  
(Temporary Traffic Restriction &  
Prohibitions) Order 2012

*Made* *8 October 2012*

*Coming into force* *15 October 2012*

The Welsh Ministers, being the traffic authority for the relevant length of the Shrewsbury – Dolgellau Trunk Road (A458) (hereinafter referred to as “the trunk road”), are satisfied that traffic in a specified length of the trunk road should be restricted or prohibited by reason of works being executed thereon.

**Title, Interpretation and Commencement**

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

1. This Order comes into force on 15 October 2012 and its title is The A458 Trunk Road (Nant yr Ehedydd, Mallwyd, Gwynedd) (Temporary Traffic Restriction & Prohibitions) Order 2012.

2. —(1) In this Order:

“exempted vehicle” (“*cerbyd esempt*”) means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

“the length of the trunk road” (“*y darn o’r gefnffordd*”) means the length of the A458 trunk road at Mallwyd in the County of Gwynedd that extends from a point 20m east of the centreline of its junction with county class road No.429 to a point 20m west of the centreline of its junction with the county unclassified road No.811;

“works period” (“*cyfnod y gwaith*”) means the period commencing at 08:00 hours on 15 October 2012 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

### **Prohibitions and Restriction**

3. Subject to the provisions of article 6, no person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to be driven in the length of the trunk road.

4. Subject to the provisions of article 6, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.

5. Subject to the provisions of article 6, no person shall, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle in the length of the trunk road during such times as the restriction referred to in article 4 is in operation.

### **Application**

6. The provisions of articles 3, 4 and 5 apply only during such times and to such extent as the application of the restriction and prohibitions referred to therein is indicated by traffic signs.

### **Duration of this Order**

7. The maximum duration of this Order shall be 6 months.
