# **ROAD TRAFFIC, WALES**

The A40 Trunk Road (Raglan Roundabout, Monmouthshire) (Temporary Traffic Restrictions and Prohibitions) Order 2012

Made 2 March 2012

Coming into force 12 March 2012

The Welsh Ministers, being the traffic authority for the relevant lengths of the Raglan – Llandovery Trunk Road (A40) (hereinafter referred to as "the trunk road"), are satisfied that traffic in specified lengths of the trunk road should be restricted and prohibited by reason of works proposed to be executed thereon.

The Welsh Ministers, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

**1.**This Order comes into force on 12 March 2012. The title to this Order is The A40 Trunk Road (Raglan Roundabout, Monmouthshire) (Temporary Traffic Restrictions and Prohibitions) Order 2012.

# **2.**—(1) In this Order:

"the lengths of the trunk road" ("y darnau o'r gefnffordd") means the lengths of the A40 trunk road at Raglan Interchange in the County of Monmouthshire specified in the Schedules to this Order;

"works period" ("cyfnod y gwaith") means that period commencing at 20.00 hours on 12 March 2012 and ending when the temporary traffic signs are permanently removed;

"exempted vehicle" ("cerbyd esempt") means any vehicle being used for the emergency services or in connection with the works giving rise to this Order.

(2) Any reference in this Order to a numbered article or Schedule is a reference to the article or Schedule bearing that number in this Order.

- **3.** Subject to the provisions of article 7, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour, in the length of the trunk road specified in Schedule 1.
- **4.** Subject to the provisions of article 7, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour, in the lengths of the trunk road specified in Schedule 2.
- **5.** Subject to the provisions of article 7, no person shall, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle in the lengths of the trunk road specified in Schedule 2, during such times as the restriction referred to in article 4 is in force.
- **6.** Subject to the provisions of article 7, no person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed in the length of the trunk road specified in Schedule 3.
- **7.**The provisions of articles 3, 4, 5 and 6 shall apply only during such times and to such extent as the application of the restrictions and prohibitions referred to therein are indicated by traffic signs.
- **8.** The maximum duration of this Order shall be 12 months.

## SCHEDULE 1

## **TEMPORARY 40 MPH SPEED LIMIT**

That length of the westbound carriageway of the trunk road which extends from a point 800 metres east of the centre-point of Raglan Interchange to a point 200 metres east of the centre-point of Raglan Roundabout.

#### **SCHEDULE 2**

# TEMPORARY 10 MPH SPEED LIMIT AND PROHIBITION OF OVERTAKING

- i) That length of the westbound carriageway of the trunk road which extends from a point 200 metres east of the centre-point of Raglan Roundabout to a point at its junction with the circulatory carriageway of Raglan Roundabout.
- ii) The entire length of the circulatory carriageway of Raglan Roundabout.

### **SCHEDULE 3**

#### **TEMPORARY PROHIBITION OF VEHICLES**

That length of the eastbound carriageway of the trunk road which extends from a point at its junction with the circulatory carriageway of Hardwick Interchange to a point at its junction with the circulatory carriageway of Raglan Roundabout.
