The A4042 Trunk Road (Llanellen to Hardwick Gyratory, Abergavenny, Monmouthshire) (Temporary Traffic Restrictions and Prohibitions) Order 2013

Made 10 January 2013

Coming into force 21 January 2013

The Welsh Ministers, being the traffic authority for the relevant lengths of the Newport to Shrewsbury Trunk Road (A4042), (hereinafter referred to as "the trunk road"), are satisfied that traffic in specified lengths of the trunk road should be restricted and prohibited by reason of works proposed to be executed thereon.

The Welsh Ministers, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

Title, Interpretation and Commencement

1.This Order comes into force on 21 January 2013. The title to this Order is The A4042 Trunk Road (Llanellen to Hardwick Gyratory, Abergavenny, Monmouthshire) (Temporary Traffic Restrictions and Prohibitions) Order 2013

2.—(1) In this Order:

"the lengths of the trunk road" ("y darnau o'r gefnffordd") means the lengths of the A4042 trunk road from Llanellen to Hardwick Gyratory, Abergavenny, in the County of Monmouthshire specified in the Schedules to this Order;

"works period" ("cyfnod y gwaith") means that period commencing at 20.00 hours on 21 January 2013 and ending when the temporary traffic signs are permanently removed;

"exempted vehicle" ("cerbyd esempt") means any vehicle being used for the emergency services or in connection with the works giving rise to this Order.

(2) Any reference in this Order to a numbered article or Schedule is a reference to the article or Schedule bearing that number in this Order.

Prohibitions and Restrictions

- **3.**Subject to the provisions of article 8, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour, in the lengths of the trunk road specified in Schedule 1.
- **4.** Subject to the provisions of article 8, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour, in the lengths of the trunk road specified in Schedules 1 and 2.
- **5.** Subject to the provisions of article 8, no person shall, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle in the lengths of the trunk road specified in Schedules 1 and 2, during such times as the restriction referred to in article 4 is in force.
- **6.** Subject to the provisions of article 8, no person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed in the lengths of the trunk road specified in Schedule 3.

Suspension

7. The provisions of The A4042 Trunk Road (Llanellen, Abergavenny, Monmouthshire) (40 MPH Speed Limit) Order 2002 (3) are hereby suspended in respect of the lengths of the trunk road specified in Schedules 1 and 2 during such times as the restrictions specified in article 4 are in operation.

Application

8. The provisions of articles 3, 4, 5 and 6 shall apply only during such times and to such extent as the application of the restrictions and prohibitions referred to therein are indicated by traffic signs.

Duration of this Order.

9. The maximum duration of this Order shall be 6 months.

SCHEDULE 1

TEMPORARY 40 MPH, 10 MPH SPEED LIMITS AND PROHIBITION OF OVERTAKING

- i) That length of the trunk road north of Llanellen which extends from a point 399 metres north of the centre-point of its junction with the B4269 to a point at its junction with the Hardwick Gyratory, Abergayenny.
- ii) That length of the trunk road, south of Llanellen, which extends from a point 603 metres south of the centre-point of its junction with the B4269 to a point 103 metres south of the centre-point of its junction with the B4269.

SCHEDULE 2

TEMPORARY 10 MPH SPEED LIMIT AND PROHIBITION OF OVERTAKING

That length of the trunk road at Llanellen which extends from a point 103 metres south of the centrepoint of its junction with the B4269, to a point 399 metres north of the centre-point of its junction with the B4269.

SCHEDULE 3

TEMPORARY PROHIBITION OF VEHICLES

That length of the trunk road which extends from a point at its junction with the B4269 to a point at its junction with the Hardwick Gyratory, Abergavenny.
