ROAD TRAFFIC, WALES

The A40 Trunk Road (Lanlash Farm to Broad Oak, Carmarthenshire) (Temporary Prohibition of Vehicles) Order 2013

Made 23 May 2013

Coming into force 1 June 2013

The Welsh Ministers, being the traffic authority for the relevant length of the Llandeilo – Carmarthen Trunk Road (A40) (hereinafter referred to as "the trunk road"), are satisfied that traffic in a specified length of the trunk road should be prohibited by reason of works proposed to be executed thereon.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 1 June 2013. Its title is The A40 Trunk Road (Lanlash Farm to Broad Oak, Carmarthenshire) (Temporary Prohibition of Vehicles) Order 2013.

2.—(1) In this Order:

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

"the length of the trunk road" ("y darn o'r gefnffordd") means that length of the A40 Trunk Road in the County of Carmarthenshire which extends from a point at the eastern extent of the access to the property known as Lanlash Farm to a point 280 metres east of the centre-point of the Class 3 road to Llangathen;

"works period" ("cyfnod y gwaith") means the period commencing at 00:01 hours on 1 June 2013 and ending when the works giving rise to this Order are complete.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Prohibition

3. Subject to the provisions of article 4, no person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed in the length of the trunk road.

Application

4. The provisions of article 3 apply only during such times and to such an extent as the application of the prohibition referred to therein is indicated by traffic signs.

Duration of this Order

5. The maximum duration of this Order shall be 18 months.
