The A48 and A466 Trunk Roads
(High Beech Roundabout, Near
Chepstow, Monmouthshire)
(Temporary Traffic Restrictions and
Prohibition) Order 2013

Made 10 January 2013

Coming into force 21 January 2013

The Welsh Ministers, being the traffic authority for the relevant lengths of the London – Fishguard Trunk Roads (A48 and A466) (hereinafter referred to as "the trunk roads"), are satisfied that traffic in specified lengths of the trunk road should be prohibited and restricted by reason of works proposed to be executed thereon.

The Welsh Ministers, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

Title, Interpretation and Commencement

1.This Order comes into force on 21 January 2013. The title to this Order is The A48 and A466 Trunk Roads (High Beech Roundabout, Near Chepstow, Monmouthshire) (Temporary Traffic Restrictions and Prohibition) Order 2013.

2.—(1)In this Order:

"the lengths of the trunk roads" ("y darnau o'r cefnffyrdd") means the lengths of the A48 and A466 trunk roads at High Beech Roundabout and approaches, near Chepstow, in the County of Monmouthshire, described in the Schedules to this Order;

"works period," ("cyfnod y gwaith") means that period commencing at 20.00 hours on 21 January 2013 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article or Schedule is a reference to the article or Schedule bearing that number in this Order.

Prohibition and Restrictions

- **3.** Subject to the provisions of article 6, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road specified in Schedule 2.
- **4.** Subject to the provisions of article 6, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road specified in Schedule 1.
- **5.** Subject to the provisions of article 6, no person shall, during the works period, use or permit the use of a vehicle in such a way that it overtakes any other vehicle in the length of the trunk road specified in Schedule 1, during such times as the restriction referred to in article 5 is in operation.

Application

6. The provisions of article 3, 4 and 5 shall apply only during such times and to such extent as the application of the prohibition and restrictions referred to therein is indicated by traffic signs.

Duration of this Order

7. The maximum duration for this Order shall be 12 months.

SCHEDULE 1

Temporary 10 mph speed limit and prohibition of overtaking.

That length of the A466 Trunk Road which extends from a point 29 metres south of its junction with the circulatory carriageway of High Beech Roundabout to a point on the A48 Trunk Road 113 metres north east of its junction with the circulatory carriageway of High Beech Roundabout including the entire circulatory carriageway of High Beech Roundabout.

SCHEDULE 2

Temporary 40 mph speed limit.

That length of the A466 Trunk Road which extends from a centre-point of Mathern Road under-bridge to a point 29 metres south of its junction with the circulatory carriageway of High Beech Roundabout.
