The A479 Trunk Road (Glanusk Park to Llyswen, Powys) (Temporary Traffic Prohibitions and Restrictions) Order 2013

Made

20 September 2013

Coming into force

30 September 2013

The Welsh Ministers, being the traffic authority for the relevant lengths of the Glanusk Park (Crickhowell) – Llyswen Trunk Road (A479) (hereinafter referred to as "the trunk road"), are satisfied that traffic in specified lengths of the trunk road should be prohibited and restricted by reason of works proposed to be executed thereon.

The Welsh Ministers, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 30 September 2013. The title to this Order is The A479 Trunk Road (Glanusk Park to Llyswen, Powys) (Temporary Traffic Prohibitions and Restrictions) Order 2013.

2.—(1) In this Order:

"the lengths of the trunk road" ("*y darnau o'r gefnffordd*") means the lengths of the A479 trunk road in the County of Powys specified in the Schedules to this Order;

"exempted vehicle" ("*cerbyd esempt*") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

"works period," ("*cyfnod y gwaith*") means that period commencing at 08.00 hours on 30 September 2013 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article or Schedule is a reference to the article or Schedule bearing that number in this Order.

Prohibitions and Restrictions

3. Subject to the provisions of article 8, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road specified in Schedule 1.

4. Subject to the provisions of article 8, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour in the length of the trunk road specified in Schedule 1.

5. Subject to the provisions of article 8, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road specified in Schedule 1.

6. Subject to the provisions of article 8, no person shall, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle in the length of the trunk road specified in Schedule 1 during such times as the restriction referred to in article 5 is in operation.

7. Subject to the provisions of article 8, no person shall drive or cause or permit any vehicle with a width of or exceeding 2.5 metres to proceed in the length of the trunk road specified in Schedule 2.

Application

8. The provisions of articles 3, 4, 5, 6 and 7 shall apply only during such times and to such extent as the application of the prohibition and restriction referred to therein is indicated by traffic signs.

Duration of this Order

9. The maximum duration for this Order shall be 12 months.

SCHEDULE 1

PROHIBITION OF VEHICLES

The length of the A479 trunk road in the County of Powys which extends from the centre-point of its junction with the A40 at Glanusk Park in a northerly direction to the centre-point of its junction with the A470 at Llyswen.

SCHEDULE 2

PROHIBITION OF VEHICLES OVER 2.5 METRES WIDE

The length of the A479 trunk road at Pont Waun Fach the County of Powys which extends from the centrepoint of its junction with the U0163, south of Pont Waun Fach to the centre-point of its junction with the U0166, north of Pont Waun Fach.
