# **ROAD TRAFFIC, WALES**

The A458 Trunk Road (Raven Roundabout, Welshpool to Nant-y-Dugoed, Powys) (Temporary Traffic Prohibition and Restrictions) Order 2013

Made

30 September 2013

Coming into force

7 October 2013

The Welsh Ministers, being the traffic authority for the relevant length of the Shrewsbury – Dolgellau Trunk Road (A458) (hereinafter referred to as "the trunk road"), are satisfied that traffic in a specified length of the trunk road should be prohibited and restricted by reason of works proposed to be executed thereon.

The Welsh Ministers, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

## Title, Interpretation and Commencement

1. This Order comes into force on 7 October 2013. The title to this Order is The A458 Trunk Road (Raven Roundabout, Welshpool to Nant-y-Dugoed, Powys) (Temporary Traffic Prohibition and Restrictions) Order 2013.

### **2.**—(1) In this Order:

"the length of the trunk road" ("y darn o'r gefnffordd") means the length of the A458 trunk road in the County of Powys which extends from its junction with Raven Roundabout, Welshpool to the Powys/Gwynedd county boundary at Nant-y-Dugoed;

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

"works period," ("cyfnod y gwaith") means that period commencing at 08.00 hours on 7 October 2013 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

### **Prohibition and Restrictions**

- **3.** Subject to the provisions of article 7, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road.
- **4.** Subject to the provisions of article 7, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour in the length of the trunk road.
- **5.** Subject to the provisions of article 7, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.
- **6.** Subject to the provisions of article 7, no person shall, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle in the length of the trunk road, during such times as the restriction referred to in article 5 is in operation.

#### **Application**

7. The provisions of articles 3, 4, 5 and 6 shall apply only during such times and to such extent as the application of the prohibition and restriction referred to therein is indicated by traffic signs.

#### **Duration of this Order**

**8.** The maximum duration for this Order shall be 12 months.
