ROAD TRAFFIC, WALES

The A458 Trunk Road (Raven Street, Welshpool, Powys) (Temporary Prohibition of Vehicles) Order 2013

Made 11 February 2013

Coming into force 18 February 2013

The Welsh Ministers, being the traffic authority for the relevant length of the Shrewsbury – Dolgellau Trunk Road (A458) (hereinafter referred to as "the trunk road"), are satisfied that traffic in a specified length of the trunk road should be prohibited by reason of works proposed to be executed thereon.

The Welsh Ministers, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

Title, Interpretation and Commencement

1.This Order comes into force on 18 February 2013. The title to this Order is The A458 Trunk Road (Raven Street, Welshpool, Powys) (Temporary Prohibition of Vehicles) Order 2013.

2.— In this Order:

"the length of the trunk road" ("y darn o'r gefnffordd") means the length of the trunk road known as Raven Street, Welshpool in the County of Powys which extends from the centre-point of its junction with High Street and Jehu Road to a point at its junction with Raven Roundabout;

"works period," ("cyfnod y gwaith") means that period commencing at 18.00 hours on 18 February 2013 and ending when the temporary traffic signs are permanently removed;

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

(1) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Prohibition

3.Subject to the provisions of article 4, no person shall, during the works period, drive or cause or permit any vehicle to proceed along the length of the trunk road.

Application

4.The provisions of article 3 shall apply only during such times and to such extent as the application of the prohibition referred to therein is indicated by traffic signs.

Duration of this Order

5.The maximum duration for this Order shall be 12 months.
