ROAD TRAFFIC, WALES

The A477 Trunk Road (Kilgetty Roundabout to Old Amroth Road Junction, Pembrokeshire) (Temporary Traffic Prohibitions and Restrictions) Order 2013

Made 21 November 2013

Coming into force 1 December 2013

The Welsh Ministers, being the traffic authority for the relevant lengths of the St Clears – Pembroke Dock Trunk Road (A477) (hereinafter referred to as "the trunk road"), are satisfied that traffic in specified lengths of the trunk road should be prohibited and restricted by reason of works proposed to be executed thereon.

The Welsh Ministers, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 1 December 2013. The title to this Order is The A477 Trunk Road (Kilgetty Roundabout to Old Amroth Road Junction, Pembrokeshire) (Temporary Traffic Prohibitions and Restrictions) Order 2013.

2.—(1) In this Order:

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

"the lengths of the trunk road" ("y darn o'r gefnffyrdd") means the lengths of the trunk road, in the County of Pembrokeshire, specified in the Schedules to this Order;

"works period," ("cyfnod y gwaith") means that period commencing at 00.01 hours on 1 December 2013 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article or Schedule is a reference to the article or Schedule bearing that number in this Order.

Prohibitions and Restrictions

- **3.** Subject to the provisions of article 9, no person shall, during the works period, use or permit any vehicle, other than an exempted vehicle, to leave the trunk road by turning right in the lengths of the trunk road specified in Schedule 2.
- **4.** Subject to the provisions of article 9, no person shall, during the works period, use or permit any vehicle, other than an exempted vehicle, to leave the trunk road by turning left in the length of the trunk road specified in Schedule 3.
- **5.** Subject to the provisions of article 9, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour, in the length of the trunk road specified in Schedule 1.
- **6.** Subject to the provisions of article 9, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour, in the length of the trunk road specified in Schedule 1.
- 7. Subject to the provisions of article 9, no person shall, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle in the lengths of the trunk road specified in Schedule 1 during such times as the restriction referred to in article 6 is in force.

Suspension

8. The provisions of The Trunk Road (A477) (Kilgetty, Dyfed) (De-Restriction) Order 1991(3) are hereby suspended in respect of the lengths of the trunk road specified in the Schedule 1 to this Order during such times as the restrictions specified in articles 5 and 6 are in operation.

Application

9. The provisions of article 3, 4, 5, 6, 7 and 8 shall apply only during such times and to such extent as the application of the prohibitions and restrictions referred to therein are indicated by traffic signs.

Duration of this Order

10. The maximum duration for this Order shall be 18 months.

SCHEDULE 1

EXTENT OF TEMPORARY 40 AND 10 MPH SPEED LIMITS AND PROHIBITION OF OVERTAKING

That length of the trunk road which extends from its junction with the main circulatory carriageway of Kilgetty Roundabout to a point 100 metres east of the centre-point of its junction with Old Amroth Road (C3185).

SCHEDULE 2

EXTENT OF TEMPORARY PROHIBITION OF RIGHT HAND TURNS

- i) From the westbound carriageway of the trunk road across the eastbound carriageway into the C3185 to Kilgetty.
- ii) From the eastbound carriageway of the trunk road across the westbound carriageway into the C3185 to Stepaside.

SCHEDULE 3

EXTENT OF TEMPORARY PROHIBITION OF LEFT HAND TURNS

From the westbound carriageway of the trunk road into the C3185 to Stepaside.
