The Welsh Ministers make the following Regulations in exercise of the powers conferred on them by section 60 of and paragraphs 4 and 6 of Schedule 8 to the Local Government Finance Act 1988 (1).

Title, commencement, application and interpretation

- **1.** (1) The title of these Regulations is The Non-Domestic Rating Contributions (Wales) (Amendment) Regulations 2013 and they come into force on 31 December 2013.
 - (2) These Regulations apply in relation to Wales.
- (3) In these Regulations "the 1992 Regulations" ("*Rheoliadau 1992*") means The Non-Domestic Rating Contributions (Wales) Regulations 1992(2).

Amendment to the 1992 Regulations

- **2.** (1) The 1992 Regulations are amended as follows in relation to financial years beginning on or after 1 April 2014.
 - (2) For Schedule 4 to the 1992 Regulations substitute the Schedule to these Regulations.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations, which apply in relation to Wales, amend the Non-Domestic Rating Contributions (Wales) Regulations 1992 (S.I. 1992/3238) ("the 1992 Regulations").

Status: This is the original version (as it was originally made). This item of legislation is currently only available in its original format.

Under Part II of Schedule 8 to the Local Government Finance Act 1988 (c.41), billing authorities (in Wales, county and county borough councils) are required to pay amounts (called non-domestic rating contributions) to the Welsh Ministers. The 1992 Regulations contain rules for the calculation of those contributions for Welsh billing authorities.

These Regulations amend the 1992 Regulations by substituting a new Schedule 4 (Adult Population Figures).
