**The A470 Trunk Road (Clatter to
Nant Wgi, Powys) (Temporary
Traffic Prohibition and Restrictions)
Order 2013**

Made 6 December 2013

Coming into force 16 December 2013

The Welsh Ministers, being the traffic authority for the relevant length of the Caersws – Machynlleth Trunk Road (A470) (hereinafter referred to as “the trunk road”), are satisfied that traffic in a specified length of the trunk road should be prohibited and restricted by reason of works proposed to be executed thereon.

The Welsh Ministers, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

1. This Order comes into force on 16 December 2013. The title to this Order is The A470 Trunk Road (Clatter to Nant Wgi, Powys) (Temporary Traffic Prohibition and Restrictions) Order 2013.

2. —1) In this Order:

“exempted vehicle” (“*cerbyd esempt*”) means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

“the length of the trunk road” (“*y darn o’r gefnffordd*”) means the length of the trunk road in the County of Powys which extends from the centre-point of its junction with the C2159 to the centre-point of the access road to the residential property known as Tycoch;

“works period,” (“*cyfnod y gwaith*”) means that period commencing at 19.00 hours on 16 December 2013 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

3. Subject to the provisions of article 8, no person shall, during the works period, drive or cause or permit any vehicle with a width of or exceeding 2.5 metres to proceed in the length of the trunk road.

4. Subject to the provisions of article 8, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road.

5. Subject to the provisions of article 8, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour in the length of the trunk road.

6. Subject to the provisions of article 8, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.

7. Subject to the provisions of article 8, no person shall, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle in the length of the trunk road, during such times as the restriction referred to in article 6 is in operation.

8. The provisions of articles 3, 4, 5, 6 and 7 shall apply only during such times and to such extent as the application of the prohibition and restrictions referred to therein is indicated by traffic signs.

9. The maximum duration for this Order shall be 6 months.
