# **ROAD TRAFFIC, WALES**

The A477 Trunk Road (Nash Fingerpost Junction, East of Pembroke Dock, Pembrokeshire) (Temporary Traffic Prohibition and Restrictions) Order 2013

Made 30 December 2013

Coming into force 6 January 2014

The Welsh Ministers, being the traffic authority for the relevant length of the St Clears – Pembroke Dock Trunk Road (A477) (hereinafter referred to as "the trunk road"), are satisfied that traffic in a specified length of the trunk road should be prohibited or restricted by reason of works being executed thereon.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

## **Title, Interpretation and Commencement**

**1.** This Order comes into force on 6 January 2014. Its title is The A477 Trunk Road (Nash Fingerpost Junction, East of Pembroke Dock, Pembrokeshire) (Temporary Traffic Prohibition and Restrictions) Order 2013.

**2.**—(1) In this Order:

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

"the length of the trunk road" ("y darn o'r gefnffordd") means the length of the A477 trunk road at Nash Fingerpost Junction, east of Pembroke Dock in the County of Pembrokeshire that extends from the access to the property known as Lower Nash Farm, approximately 185 metres west of Nash Fingerpost Junction, to its junction with Blackberry Lane;

"works period" ("*cyfnod y gwaith*") means the period commencing at 00:01 hours on 6 January 2014 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

## **Restrictions & Prohibition**

**3.** Subject to the provisions of article 6, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road.

**4.** Subject to the provisions of article 6, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.

**5.** Subject to the provisions of article 6, no person shall, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle in the length of the trunk road during such times as the restriction referred to in article 4 is in operation.

## Application

**6.** The provisions of articles 3, 4 and 5 apply only during such times and to such extent as the application of the prohibition and restrictions referred to therein are indicated by traffic signs.

#### **Duration of this Order**

**7.** The maximum duration of this Order shall be 18 months.
