Coming into force 5 March 2013

The Welsh Ministers, being the traffic authority for the relevant lengths of the Neath – Abergavenny Trunk Road (A465) (hereinafter referred to as "the trunk road"), are satisfied that traffic in specified lengths of the trunk road should be prohibited or restricted by reason of works proposed to be executed thereon.

The Welsh Ministers, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 5 March 2013. The title to this Order is The A465 Trunk Road (Cefncoed-y-cymmer Roundabout, Merthyr Tydfil to Hirwaun Roundabout, Rhondda Cynon Taf) (Temporary Prohibition of Vehicles & 50 mph Speed Limit) Order 2013.

2.—1) In this Order:

"exempted vehicle" ("cerbyd esempt") means any vehicle being used for the emergency services or in connection with the works giving rise to this Order;

"the lengths of the trunk road" ("y darnau o'r gefnffordd") means those lengths of the A465 trunk between Cefn-coed-yCymmer in the County Borough

of Merthyr Tydfil and Hirwaun Roundabout in the County Borough of Rhondda Cynon Taf specified in the Schedules to this Order;

"works period" ("cyfnod y gwaith") means that period commencing at 20:00 hours on 5 March 2013 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Prohibition and Restrictions

- **3.** Subject to the provisions of article 6, no person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed in the length of the trunk road specified in Schedule 1 to this Order.
- **4.** Subject to the provisions of article 6, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 50 miles per hour in the length of the trunk road specified in Schedule 2 to this Order.

Suspension

5. The provisions of The A465 Trunk Road (Rhigos Roundabout, Rhondda Cynon Taf to Dowlais Top Roundabout, Merthyr Tydfil) (De-Restriction) Order 2013(3) are hereby suspended in respect of the length of highway specified in Schedule 2 during such times as the restriction specified in article 4 is in operation.

Application

6. The provisions of articles 3 and 4 shall apply only at such times and to such extent as traffic signs indicate the application of the prohibition or restriction referred to therein.

Duration of this Order

7. The maximum duration for this Order shall be 18 months.

SCHEDULE 1 Temporary Prohibition of Vehicles

That length of the trunk road which extends from its junction with the western side of the Cefn-coed-y-cymmer Roundabout to its junction with the eastern side of the Hirwaun Roundabout.

SCHEDULE 2 Temporary 50 mph Speed Limit

That length of the trunk road which extends from its junction with the eastern side of the Hirwaun Roundabout to the centre point of the Baverstocks Junction.
