The A470 Trunk Road (Abercynon Roundabout, Rhondda Cynon Taf to Abercanaid Roundabout, Merthyr Tydfil) (Temporary Prohibition of Vehicles, Cyclists and Pedestrians) Order 2014

Coming into force	9 May 2014

The Welsh Ministers, being the traffic authority for the relevant length of the Cardiff – Llangurig Trunk Road (A470) (hereinafter referred to as "the trunk road"), are satisfied that traffic in a specified length of the trunk road should be prohibited by reason of works proposed to be executed thereon.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 9 May 2014 and its title is The A470 Trunk Road (Abercynon Roundabout, Rhondda Cynon Taf to Abercanaid Roundabout, Merthyr Tydfil) (Temporary Prohibition of Vehicles, Cyclists and Pedestrians) Order 2014.

2.—(1) In this Order:

"exempted vehicle" ("*cerbyd esempt*") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

"the length of the trunk road" ("y darn o'r gefnffordd") means the length of the northbound carriageway of the trunk road in the County Boroughs of Merthyr Tydfil and Rhondda Cynon Taf that extends from the northern side of Abercynon Roundabout to the southern side of Abercanaid Roundabout;

"works period" ("*cyfnod y gwaith*") means that period commencing at 21:00 hours on 9 May 2014 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Prohibitions

3. Subject to the provisions of article 6, no person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed in the length of the trunk road.

4. Subject to the provisions of article 6, no person shall, during the works period, ride or cause to be ridden, any pedal cycle in the length of the trunk road.

5. Subject to the provisions of article 6, no pedestrian shall, during the works period, proceed in the length of the trunk road.

Application

6. The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as the application of the prohibitions referred to therein is indicated by traffic signs.

Duration of this Order

7. The maximum duration of this Order shall be 18 months.
