# ROAD TRAFFIC, WALES

The A487 Trunk Road (Llanrhystud to Llanfarian, Ceredigion) (Temporary Speed Restrictions & No Overtaking) Order 2014

*Made* 2 *June* 2014

Coming into force 9 June 2014

The Welsh Ministers, being the traffic authority for the relevant length of the Fishguard – Bangor Trunk Road (A487) (hereinafter referred to as "the trunk road"), are satisfied that traffic in a specified length of the trunk road should be restricted or prohibited by reason of works proposed to be executed thereon.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

### **Title, Interpretation and Commencement**

**1.** This Order comes into force on 9 June 2014 and its title is The A487 Trunk Road (Llanrhystud to Llanfarian, Ceredigion) (Temporary Speed Restrictions & No Overtaking) Order 2014.

#### **2.**—(1) In this Order:

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

"the length of the trunk road" ("y darn o'r gefnffordd") means the length of the trunk road in the County of Ceredigion that extends from the centrepoint of its junction with the U1207, north of Llanrhystud to the centre-point of its junction with the A485 at Llanfarian:

"works period" ("cyfnod y gwaith") means the period commencing at 07:30 hours on 9 June 2014 and ending

when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

#### **Restrictions and Prohibition**

- **3.** Subject to the provisions of article 9, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road.
- **4.** Subject to the provisions of article 9, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour in the length of the trunk road.
- **5.** Subject to the provisions of article 9, no person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.
- **6.** Subject to the provisions of article 9, no person shall, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle in the length of the trunk road during such times as the restriction referred to in article 5 is in operation.

#### **Suspensions**

- **7.** The provisions of The A487 Trunk Road (Southern Approach to Llanfarian, Aberystwyth, Ceredigion) (40 mph Speed Limit) Order 2003(3) are hereby suspended insofar as they apply to the length of the trunk road during such times as the restrictions specified in articles 4 and 5 are in operation.
- **8.** The provisions of The County Council of Cardigan (Built Up Areas) Order 1936 are hereby suspended insofar as they apply to the length of the trunk road during such times as the restriction specified in article 5 is in operation.

#### **Application**

**9.** The provisions of articles 3, 4, 5, 6, 7 and 8 apply only during such times and to such extent as the application of the restrictions and prohibition referred to therein is indicated by traffic signs.

#### **Duration of this Order**

**10.** The maximum duration of this Order shall be 12 months.
