The A494 Trunk Road (Mold Bypass, Flintshire) (Temporary Prohibition of Vehicles & Cyclists) (No.2) Order 2014

Made 25 June 2014
Coming into force 30 June 2014

The Welsh Ministers, being the traffic authority for the relevant length of the Dolgellau – South of Birkenhead Trunk Road (A494) (hereinafter referred to as "the trunk road"), are satisfied that traffic in a specified length of the trunk road should be prohibited by reason of works proposed to be executed thereon.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 30 June 2014 and its title is The A494 Trunk Road (Mold Bypass, Flintshire) (Temporary Prohibition of Vehicles & Cyclists) (No.2) Order 2014.

2. (1) In this Order:

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

"the length of the trunk road" ("y darn o'r gefnffordd") means the length of the trunk road known as Mold Bypass in the County of Flintshire that extends from its junction with the eastern side of the A494/A5119 roundabout south of Mold to its junction with the southern side of the A494/A549/A541 roundabout east of Mold;

"works period" ("cyfnod y gwaith") means the period commencing at 19:00 hours on 30 June 2014

and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Prohibitions

- **3.** Subject to the provisions of article 5, no person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to be driven in the length of the trunk road.
- **4.** Subject to the provisions of article 5, no person shall, during the works period, ride or cause any pedal cycle to be ridden in the length of the trunk road.

Application

5. The provisions of articles 3 and 4 apply only during such times and to such extent as the application of the prohibitions referred to therein is indicated by traffic signs.

Duration of this Order

6. The maximum duration of this Order shall be 12 months.
