ROAD TRAFFIC, WALES

The M4 Motorway (Junction 23A, Magor, Monmouthshire) (Temporary Prohibition of Vehicles) Order 2014

Made	11 August 2014
Coming into force	15 August 2014

The Welsh Ministers, being the traffic authority for the relevant lengths of the London – South Wales Motorway (M4) (hereinafter referred to as "the motorway"), are satisfied that traffic in specified lengths of the motorway should be prohibited by reason of works proposed to be executed thereon or near to.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 15 August 2014. Its title is The M4 Motorway (Junction 23A, Magor, Monmouthshire) (Temporary Prohibition of Vehicles) Order 2014.

2.—(1) In this Order:

"exempted vehicle" ("*cerbyd esempt*") means any vehicle being used for the emergency services or in connection with the works giving rise to this Order;

"the lengths of the motorway" ("*y darnau o'r draffordd*") means the lengths of the motorway at Junction 23A, Magor in the County of Monmouthshire specified in the Schedule to this Order;

"works period" ("*cyfnod y gwaith*") means that period commencing at 20:00 hours on 15 August 2014 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Prohibition

3. Subject to the provisions of article 4, no person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed in the lengths of the motorway specified in the Schedule.

Application

4. The provisions of article 3 apply only during such times and to such extent as the application of the prohibition referred to therein is indicated by traffic signs.

Duration of this Order

5. The maximum duration for this Order shall be 18 months.

SCHEDULE

Lengths of the M4 Motorway at Junction 23A, Magor in the County of Monmouthshire

i) The entire length of the westbound off slip road.

ii) The entire length of the eastbound off slip road.

iii) That length of the main westbound carriageway of the motorway that extends from the nosing of the westbound off slip road to the nosing of the westbound on slip road.
