# **ROAD TRAFFIC, WALES**

The A40 Trunk Road (East of Llandovery, Carmarthenshire) (Temporary Traffic Restrictions and Prohibitions) Order 2014

Made

19 September 2014 26 September 2014

Coming into force

The Welsh Ministers, being the traffic authority for the relevant length of the Raglan – Llandovery Trunk Road (A40) ("the trunk road"), are satisfied that traffic in a specified length of the trunk road should be prohibited and restricted because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

#### **Title, Interpretation and Commencement**

**1.** This Order comes into force on 26 September 2014 and its title is The A40 Trunk Road (East of Llandovery, Carmarthenshire) (Temporary Traffic Restrictions and Prohibitions) Order 2014.

#### **2.**—(1) In this Order:

"exempted vehicle" ("*cerbyd esempt*") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

"the length of the trunk road" ("*y* darn o'r gefnffordd") means the length of the trunk road in the County of Carmarthenshire that extends from the eastern extent of the permanent 30 mph speed limit at Llandovery to the western edge of the dwelling known as Tafarn Newydd to the east of Llandovery;

"works period" (*"cyfnod y gwaith"*) means the period commencing at 00:01 hours on 26 September 2014 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

#### **Prohibitions and Restrictions**

**3.** Subject to the provisions of article 7, no person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed in the length of the trunk road.

**4.** Subject to the provisions of article 7, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road.

**5.** Subject to the provisions of article 7, no person shall, during the works period, ride, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.

**6.** Subject to the provisions of article 7, no person shall, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle in the length of the trunk road during such times as the restriction referred to in article 5 is in operation.

#### Application

**7.** The provisions of articles 3, 4, 5 and 6 shall apply only during such times and to such extent as the application of the prohibitions and restrictions referred to therein is indicated by traffic signs.

#### **Duration of this Order**

**8.** The maximum duration for this Order shall be 18 months.
