# ROAD TRAFFIC, WALES

The A465 Trunk Road (Westbound Off-Slip Road, Llanfoist Interchange, Monmouthshire) (Temporary Prohibition of Vehicles) Order 2015

Made

18 August 2015

Coming into force

1 September 2015

The Welsh Ministers, being the traffic authority for the relevant length of the Neath – Abergavenny Trunk Road (A465) ("the trunk road"), are satisfied that traffic in a specified length of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

## Title, Interpretation and Commencement

1. This Order comes into force on 1 September 2015. Its title is The A465 Trunk Road (Westbound Off-Slip Road, Llanfoist Interchange, Monmouthshire) (Temporary Prohibition of Vehicles) Order 2015.

# **2.**—(1) In this Order:

"exempted vehicle" ("cerbyd esempt") means any vehicle being used for the emergency services or in connection with the works giving rise to this Order;

"the length of the trunk road" ("y darn o'r gefnffordd") means the entire length of the westbound off slip road of the A465 trunk road at Llanfoist Interchange in the County of Monmouthshire.

"works period" ("cyfnod y gwaith") means intermittent periods commencing at 20:00 hours on 1 September 2015 and ending when the temporary traffic signs for each period of works are removed

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

#### **Prohibition**

**3.** Subject to the provisions of article 4, no person shall, during the works period, drive any vehicle or cause or permit any vehicle, other than an exempted vehicle, to proceed in the length of the trunk road.

## **Application**

**4.** The provisions of article 3 shall apply only during such times and to such extent as the application of the prohibition referred to therein is indicated by traffic signs.

## **Duration of this Order**

**5.** The maximum duration for this Order shall be 6 months.
