The A40 Trunk Road (Nantarwenlliw to Pontargothi, Carmarthenshire) (Temporary Speed Restrictions & No Overtaking) Order 2015

Made 7 September 2015

Coming into force 14 September 2015

The Welsh Ministers, being the traffic authority for the relevant length of the Llandeilo – Carmarthen Trunk Road (A40) ("the trunk road"), are satisfied that traffic in a specified length of the trunk road should be restricted or prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 14 September 2015 and its title is The A40 Trunk Road (Nantarwenlliw to Pontargothi, Carmarthenshire) (Temporary Speed Restrictions & No Overtaking) Order 2015.

2.—(1) In this Order:

"the length of the trunk road" ("y darn o'r gefnffordd") means the length of the trunk road in the County of Carmarthenshire that extends from the centre-point of its junction with the B4297 Class II road (Dryslwyn Square) to a point 184m west of the centre-point of its junction with the C2053 Class III road to Llanfynydd;

"works period" ("cyfnod y gwaith") means the period commencing at 00:01 hours on 14 September 2015 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Restrictions and Prohibition

- **3.** Subject to the provisions of article 6, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road.
- **4.** Subject to the provisions of article 6, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.
- **5.** Subject to the provisions of article 6, no person shall, during the works period, use or permit the use of a vehicle in such a way that it overtakes any other vehicle in the length of the trunk road during such times as the restriction referred to in article 4 is in operation.

Application

6. The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as the application of the restrictions and prohibition referred to therein is indicated by traffic signs.

Duration of this Order

7. The maximum duration for this Order shall be 18 months.
