The A55 Trunk Road (Junction 27, Talardy Interchange, Denbighshire, Eastbound On Slip Road) (Temporary Prohibition of Vehicles, Cyclists and Pedestrians) Order 2015

Made	5 January 2015
Coming into force	11 January 2015

The Welsh Ministers, as the traffic authority for the Chester – Bangor Trunk Road (A55) ("the trunk road"), are satisfied that traffic in a specified length of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 11 January 2015. Its title is The A55 Trunk Road (Junction 27, Talardy Interchange, Denbighshire, Eastbound On Slip Road) (Temporary Prohibition of Vehicles, Cyclists and Pedestrians) Order 2015.

2.—1) In this Order:

"the length of the trunk road" ("*y* darn o'r *gefnffordd*") means the entire length of the eastbound on slip road of the trunk road at Junction 27, Talardy Interchange in the County of Denbighshire;

"works period" ("*cyfnod y gwaith*") means that period commencing at 00:01 hours on 11 January 2015 and ending when the temporary traffic signs have been removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Prohibitions

3. Subject to the provisions of article 6, no person shall, during the works period, drive or cause or permit any vehicle to proceed in the length of the trunk road.

4. Subject to the provisions of article 6, no person shall, during the works period, ride or cause to be ridden, any pedal cycle in the length of the trunk road.

5. Subject to the provisions of article 6, no pedestrian shall, during the works period, proceed in the length of the trunk road.

Application

6. The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as the application of prohibitions referred to therein are indicated by traffic signs.

Duration of this Order

7. The maximum duration for this Order shall be 12 months.
