**ROAD TRAFFIC, WALES**

**The A40 Trunk Road (Glangrwyney  
to Pont Wen, Halfway, Powys)  
(Temporary Speed Restrictions and  
No Overtaking) Order 2016**

*Made* 25 January 2016

*Coming into force* 1 February 2016

The Welsh Ministers, being the traffic authority for the relevant length of the Raglan – Llandovery Trunk Road (A40) (“the trunk road”), are satisfied that traffic in a specified length of the trunk road should be restricted and prohibited because of works proposed on or near the road.

The Welsh Ministers, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

**Title, Interpretation and Commencement**

**1.** This Order comes into force on 1 February 2016. The title to this Order is The A40 Trunk Road (Glangrwyney to Pont Wen, Halfway, Powys) (Temporary Speed Restrictions and No Overtaking) Order 2016.

**2.** —(1) In this Order:

“exempted vehicle” (“*cerbyd esempt*”) means:

(a) any vehicle being used by the emergency services; and

(b) any vehicle being used for naval, military or air force purposes and are being driven by a person for the time being subject to the orders of the member of the armed forces of the Crown, who is a member of the special forces—

(i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds: or

(ii) for the purpose of training a person in driving vehicles at high speeds.

“special forces” (*“lluoedd arbennig”*) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the length of the trunk road” (*“y darn o’r gefnffordd”*) means the length of the A40 trunk road in the County of Powys which extends from the Powys/Monmouth County boundary at Lodge Culvert, Glangrwyney in a westerly direction to the Powys/Carmarthenshire County border at Pont Wen, Halfway;

“works period” (*“cyfnod y gwaith”*) means intermittent periods commencing at 08.00 hours on 1 February 2016 and ending when the temporary traffic signs for each period of works are removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

#### **Restrictions and Prohibition**

**3.** Subject to the provisions of article 8, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road.

**4.** Subject to the provisions of article 8, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour in the length of the trunk road.

**5.** Subject to the provisions of article 8, no person shall, during the works period, ride, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.

**6.** Subject to the provisions of article 8, no person shall, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle in the length of the trunk road, during such times as the restriction referred to in article 5 is in operation.

#### **Suspension**

**7.** Any statutory provisions restricting the speed of vehicles on the relevant length of trunk road specified in article 2 are hereby suspended during such times as the restrictions specified in articles 3, 4 and 5 are in operation.

### **Application**

**8.** (1) The provisions of articles 3, 4, 5 and 6 shall apply only during such times and to such extent as the application of the restrictions and prohibition referred to therein are indicated by traffic signs.

(2) No speed limit imposed by this Order applies to an exempted vehicle.

### **Duration of this Order**

**9.** The maximum duration for this Order shall be 18 months.
