# ROAD TRAFFIC, WALES

The A4042 Trunk Road (Eastbound and Westbound Link Roads between Grove Park Roundabout and Caerleon Roundabout, Newport) (Temporary Prohibition of Vehicles) Order 2017

Made 27 November 2017

Coming into force 6 December 2017

The Welsh Ministers, being the traffic authority for the relevant lengths of the A4042 Newport to Shrewsbury Trunk Road, are satisfied that traffic in specified lengths of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

### Title, Interpretation and Commencement

1. This Order comes into force on 6 December 2017 and its title is The A4042 Trunk Road (Eastbound and Westbound Link Roads between Grove Park Roundabout and Caerleon Roundabout, Newport) (Temporary Prohibition of Vehicles) Order 2017.

#### **2.**—(1) In this Order:

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

"the link roads" ("y ffyrdd cyswllt") means the entire lengths of the A4042 eastbound and westbound link roads between Grove Park Roundabout and Caerleon Roundabout.

"works period" ("cyfnod y gwaith") means that period commencing at 20:00 hours on 6 December 2017 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

#### **Prohibition**

**3.** No person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed in the lengths of the link roads.

### **Application**

**4.** The prohibition in article 3 shall apply only during such times and to such extent as the application of the prohibition referred to therein is indicated by traffic signs.

### **Duration of this Order**

**5.** The maximum duration for this Order shall be 18 months.

# **Temporary Prohibition of Vehicles**

The entire length of the A4042 eastbound link road that extends from its junction with the circulatory carriageway of Grove Park Roundabout to its junction with the circulatory carriageway of Caerleon Roundabout.

The entire length of the A4042 westbound link road that extends from its junction with the circulatory carriageway of Caerleon Roundabout to its junction with the circulatory carriageway of Grove Park Roundabout.
