The M4 Motorway (Junction 37 (Pyle), Bridgend to Junction 47 (Penllergaer), Swansea) (Temporary Prohibition of Vehicles) Order 2018

Made 7 February 2018

Coming into Force 12 February 2018

The Welsh Ministers, being the traffic authority for the relevant length of the M4 London to South Wales Motorway, are satisfied that traffic on specified lengths of the motorway should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

Title, Commencement and Interpretation

1. The title of this Order is The M4 Motorway (Junction 37 (Pyle), Bridgend to Junction 47 (Penllergaer), Swansea) (Temporary Prohibition of Vehicles) Order 2018 and it comes into force on 12 February 2018.

2.—(1) In this Order:

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

"the motorway" ("y draffordd") means the M4 London to South Wales Motorway;

"works period" ("cyfnod y gwaith") means intermittent periods commencing at 20:00 hours on 12 February 2018 and ending when the temporary traffic signs for each period of works are removed.

(2) Any reference in this Order to a numbered article or Schedule is a reference to the article or Schedule bearing that number in this Order.

Prohibition

3. No person may, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed on the lengths of the motorway specified in the Schedule.

Application

4. The prohibition of article 3 applies only during such times and to such extent as indicated by traffic signs.

Duration of this Order

5. The maximum duration for this Order is 12 months.
