The A55 Trunk Road (Junction 4 (Dalar Hir) to Junction 8 (Ael-y-Bowl), Isle of Anglesey) (Temporary Prohibition of Vehicles)
Order 2018

Made 31 May 2018

Coming into force 4 June 2018

The Welsh Ministers, as traffic authority for the relevant length of the A55 London to Holyhead Trunk Road, are satisfied that traffic on specified lengths of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by sections 14(1), (4), (7) and 124 of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984(1), make this Order.

Title, Commencement and Interpretation

1. The title of this Order is the A55 Trunk Road (Junction 4 (Dalar Hir) to Junction 8 (Ael-y-Bowl), Isle of Anglesey) (Temporary Prohibition of Vehicles) Order 2018 and it comes into force on 4 June 2018.

2.—(1) In this Order:

"the trunk road" ("y gefnffordd") means the A55 London to Holyhead Trunk Road;

"works period" ("cyfnod y gwaith") means intermittent periods commencing at 10:00 hours on

- 4 June 2018 and ending when the temporary traffic signs for each period of works are removed.
- (2) Any reference in this Order to a numbered article or Schedule is a reference to the article or Schedule bearing that number in this Order.

Prohibitions

- **3.** No person may, during the works period, drive or cause or permit any vehicle to be driven on either the eastbound or westbound carriageway of the length of the trunk road specified in Schedule 1.
- **4.**—(1) Whilst movement of traffic is by article 3 prohibited in the eastbound carriageway but, pursuant to article 9, not prohibited in the westbound carriageway, no person shall drive, cause or permit any vehicle to proceed in the offside lane of the westbound carriageway of the trunk road in any direction other than eastwards.
- (2) Whilst movement of traffic is by article 3 prohibited in the westbound carriageway but, pursuant to article 9, not prohibited in the eastbound carriageway, no person shall drive, cause or permit any vehicle to proceed in the offside lane of the eastbound carriageway of the trunk road in any direction other than westwards.
- **5.** No person may, during the works period, cause or permit any vehicle with a width of or exceeding 3 metres to proceed on the length of the trunk road specified in Schedule 1.
- **6.** No person may, during the works period, drive or cause or permit any vehicle to be driven on the lengths of the trunk road specified in Schedules 2 and 3.

Suspensions

7. The provisions of the A55 Trunk Road (Lay-bys between Junction 2 (Trearddur Bay) & Junction 8 (Llanfair PG), Isle of Anglesey) (Restriction of Waiting) Order 2016(2), as they apply to the trunk road lay-bys between Junction 4 (Dalar Hir) and Junction 8 (Ael-y-Bowl), are suspended during the works period.

Revocation

8. The A55 Trunk Road (Slip Roads at Junction 6 (Nant Turnpike), Isle of Anglesey) (Temporary Prohibition of Vehicles) Order 2018(3) is revoked.

Application

9. The prohibitions in articles 3, 4, 5 and 6 apply only during such times and to such extent as indicated by traffic signs.

Duration of this Order

10. The maximum duration of this Order is 12 months.

SCHEDULES

Lengths of the trunk road between Junction 4 and Junction 8 on the Isle of Anglesey

SCHEDULE 1

Contraflow & Temporary Prohibition of Wide Vehicles

The length of the trunk road that extends from a point 3.07 kilometres west of the centre-point of Junction 6 (Nant Turnpike) to a point 876 metres east of the centre-point of that junction.

SCHEDULE 2 Temporary Prohibition of Vehicles

The entire lengths of the eastbound and westbound exit and entry slip roads at Junction 6 (Nant Turnpike).

SCHEDULE 3 Temporary Lay-by Closures

The entire lengths of the trunk road lay-bys between Junction 4 (Dalar Hir) and Junction 8 (Ael-y-Bowl).
