# ROAD TRAFFIC, WALES

The A55 Trunk Road (Westbound Entry and Exit Slip Roads at Junction 9, Gwynedd) and the A487 Trunk Road (Link Road between Parc Menai Roundabout and Treborth Road Roundabout, Gwynedd) (Temporary Prohibition of Vehicles, Cyclists & Pedestrians) Order 2019

Made 22 July 2019
Coming into force 26 July 2019

The Welsh Ministers, as traffic authority for the A55 and A487 Trunk Roads, are satisfied that traffic on specified lengths of the trunk roads should be prohibited because of works proposed on or near the roads.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by sections 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order

## **Title, Commencement and Interpretation**

1. The title of this Order is the A55 Trunk Road (Westbound Entry and Exit Slip Roads at Junction 9, Gwynedd) and the A487 Trunk Road (Link Road between Parc Menai Roundabout and Treborth Road Roundabout, Gwynedd) (Temporary Prohibition of

Vehicles, Cyclists & Pedestrians) Order 2019 and it comes into force on 26 July 2019.

#### **2.** In this Order:

"exempted vehicle" ("cerbyd esempt") means any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984 Act(2) or in connection with the works giving rise to this Order;

"the trunk roads" ("y cefnffyrdd") means the A55 Chester to Bangor trunk road and the A487 Fishguard to Bangor trunk road;

"works period" ("cyfnod y gwaith") means the period commencing at 19:00 on the 26 July 2019 and ending when the temporary traffic signs are permanently removed.

#### **Prohibitions**

- **3.** No person may, during the works period, drive any vehicle on the lengths of the trunk roads specified in the Schedule to this Order.
- **4.** No person may, during the works period, ride any pedal cycle on the lengths of the trunk roads specified in the Schedule to this Order.
- **5.** No pedestrian may, during the works period, proceed on the lengths of the trunk roads specified in the Schedule to this Order.

# **Application**

**6.** The prohibitions in articles 3, 4, and 5 apply only during such times and to such extent as indicated by traffic signs.

## **Duration of this Order**

**7.** The maximum duration of this Order is 12 months.

# Temporary Prohibition of Vehicles, Cyclists, Pedestrians

- 1. The length of the A55 Junction 9 westbound entry slip road.
- 2. The length of the A55 Junction 9 westbound exit slip road.
- 3. The entire length of the A487 trunk road between Parc Menai Roundabout and Treborth Road Roundabout including part of the circulatory carriageway of Parc Menai Roundabout.
